1. BILL SUMMARY

Legislation Title: A RESOLUTION affirming The City of Seattle's commitment to fostering a welcoming community that protects all its residents and declaring its support for providing permanent protection and a path to citizenship for immigrant youth and Temporary Protected Status (TPS) and Deferred Enforced Departure (DED) recipients for whom the United States is home.

Summary and background of the Legislation:

A joint resolution in support of H.R. 6: the American Dream and Promise Act of 2019, legislation from House Democrats led by Congresswomen Roybal-Allard, Velasquez, and Clarke and currently in the House Judiciary Committee. If passed by the United States Congress and signed into law by the President, the Dream and Promise Act would provide a pathway to citizenship for people who have Deferred Action for Childhood Arrival (DACA), Temporary Protected Status (TPS), or Deferred Enforcement Departure (DED).

The resolution specifically supports permanent protection and a path to citizenship for immigrant youth, including those with DACA status, and TPS and DED holders, recognizing the contributions of the over 4,300 Seattle-area residents who would be protected under the bill's provisions, and their 6,700 family members. The resolution further affirms the Seattle City Council's work to promote policies of inclusion for all Seattle residents, regardless of immigration status, and joining a nationwide effort in pursuit of a permanent legislative solution that restores certainty and protection for immigrant youth and TPS and DED recipients.
