1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to grant funds from non-City sources; authorizing the Director of the Seattle Department of Transportation to accept a specified grant and to execute, deliver, and perform corresponding agreements for and on behalf of the City; amending Ordinance 125724, which adopted the 2019 Budget, including the 2019-2024 Capital Improvement Program (CIP); changing appropriations to the Seattle Department of Transportation; revising project allocations and spending plans for certain projects in the 2019-2024 CIP; and ratifying and confirming certain prior acts; all by a 3/4 vote of the City Council.

Summary and background of the Legislation: At the end of May, the Puget Sound Regional Council (PSRC) notified the City that they would like to award an additional \$602,465 of federal Surface Transportation Program (STP) to the Cowen Park Bridge project. The reason for the award of additional funding is that the PSRC is working to meet their 2019 delivery target. In order the accept the grant, Seattle is required to obligate the funds by July 15, 2019.

This grant will free up local Move Seattle dollars in the Bridge Seismic – Phase III program which will be re-programmed within the bridge seismic/rehabilitation programs.
