**1. BILL SUMMARY**

**Legislation Title:**

AN ORDINANCE vacating a portion of 41st Avenue Northeast and a portion of Northeast 46th Street, on the petition of Seattle Children's Hospital (Clerk File 309690).

**Summary and background of the Legislation:**

This Council Bill completes the vacation process for portions of 41st Avenue Northeast and Northeast 46th Street in the Laurelhurst and Ravenna-Bryant neighborhoods, on the petition of Seattle Children's Hospital.

The Petitioner sought the vacation to support the hospital's expansion as part of the 2010 approved Major Institution Master Plan amendment. After an April 9, 2013 public hearing on the petition, the Council conditionally granted the petition.
