

Memo for Discussion Purposes Only - Seattle City Council Select Committee 07/11/2019

This memo details current investments to community-based service providers that address homelessness across King County, are administered by the City of Seattle, King County, and/or the Continuum of Care (led by All Home) and could be consolidated and administered by the new Authority.

For the new regional Authority to successfully improve outcomes for people experiencing homelessness and address fragmentation of public funding, policies, and practices, it will require oversight of funding at levels that will drive results. An early decision was made to assume homeless investments would transition to the Authority unless there was compelling rationale for keeping it with the City of Seattle or King County governments. An early decision was also made that all HUD Continuum of Care (CoC) funding and functions should be transitioned to the Authority, as those funds, by their nature, serve the County as a whole. There may investments for which the transition will be phased.

Proposal

King County DCHS, Seattle HSD and All Home jointly propose the following future distribution of duties between a new Regional Authority, Seattle, and King County.

- **Sunsetting All Home**: This memorandum assumes that All Home, the current CoC lead entity, will cease to exist upon creation of a new Regional Authority, which will assume the CoC functions formerly performed by All Home.
- **Multiple Jurisdictions**: This memorandum contemplates that other cities within King County may also "join" the Regional Authority.
- Sequence & Schedule: City of Seattle and King County staff will conduct and provide subsequent analysis and recommendation on the groupings, order, and timing with which functions should migrate to the new Regional Authority.
- Staffing & Administration: This proposal does not yet fully include staff and administration currently borne by Seattle, King County, and the CoC. Staff will conduct and provide subsequent analysis and recommendation on staffing and administration scenarios.

This proposed distribution would achieve the intent of National Innovation Services' <u>Recommend Action 2: Consolidate Homelessness Response Systems Under One Regional</u> <u>Authority</u>
