BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$23,626,072.53 on PeopleSoft 9.2 mechanical warrants numbered 4100215477 – 4100217803 plus manual or cancellation issues for claims, E-Payables of \$139,438.26 on PeopleSoft 9.2 9100003767 – 9100003834 and Electronic Financial Transactions (EFT) in the amount of \$63,407,866.64 are presented for ratification by the City Council per RCW 42.24.180.

Section 2. Payment of the sum of \$48,987,109.53 on City General Salary Fund mechanical warrants numbered 51316197 – 51317086 plus manual warrants, agencies warrants, and direct deposits numbered 270001 – 272717 representing Gross Payrolls for payroll ending date June 25, 2019 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council July 3, 2019 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.

Section 3. Any act consistent with the authority of this ordinance taken prior to its effective date is hereby ratified and confirmed.
