1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to procurement and the Arctic National Wildlife Refuge; affirming The City of Seattle's commitment to avoid procuring goods and services from corporations that purchase leases or develop oil fields in the Arctic Refuge Coastal Plain.

Summary and background of the Legislation: A provision of the Tax Cuts and Jobs Act of 2017 opened up a 1.6 million acre portion of the Arctic National Wildlife Refuge, known as the Arctic Refuge coastal plain ("coastal plain"), to oil and gas leasing, exploration, development, and production. The coastal plain is the ancestral calving grounds of the Porcupine caribou herd, and the Gwich'in people rely upon these caribou for their nutritional, cultural and spiritual needs. This resolution commits the City to avoid procuring goods and services from corporations that purchase leases or develop oil fields in the coastal plain.
