Legislation Title:

AN ORDINANCE vacating the alley in Block 81, Terry's Second Addition, and an aerial portion of 9th Avenue between Jefferson Street and Alder Street on the petition of King County (Clerk File 304408); and accepting a Property Use and Development Agreement.

Summary and background of the Legislation:

This Council Bill completes the vacation process for the alley in Block 81, Terry's Second Addition, and an aerial portion of 9th Avenue between Jefferson Street and Alder Street in the neighborhood, on the petition of King County.

The Petitioner sought the vacation to improve and expand the medical facilities at Harborview Medical Center as approved in the 2000 Major Institution Master Plan. Following a February 28, 2003 public hearing on the petition, the Council conditionally granted the petition.
