1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to the rates, terms, and conditions for the use and sale of electricity supplied by the City Light Department for 2020; amending Seattle Municipal Code (SMC) Sections 21.49.030, 21.49.052, 21.49.055, 21.49.057, and 21.49.081; adding a new Section 21.49.070 to the SMC; and ratifying and confirming certain prior acts.

Summary and background of the Legislation: This technical ordinance implements three changes associated with Department rates and charges:

- (1) Codifies 2020 electricity rates for customers within the city of Burien. The city of Burien has exercised an option in its current Franchise Agreement to increase the rate differential from 6% to 8%. In turn, the percent of Burien customer revenue used to calculate franchise payments will increase from 4% to 6%. This will be effective Jan 1, 2020.
- (2) Amends the Automatic BPA cost adjustment to only pass through material costs differences defined as over \$1.5 million. It also provides City Light with up to three months of flexibility to implement a surcharge/credit in efforts to align the BPA pass through with other scheduled rate changes.
- (3) Establishes the provisions for setting rental fees for the use of City Light charging stations. Rental fees are to recover the costs of owning and operating the charging stations and energy services will be recovered with the applicable retail rate.
