### 1. BILL SUMMARY

**Legislation Title:** AN ORDINANCE relating to the sale and use of tobacco and marijuana products to and by minors; amending Sections 6.240.010 and 6.240.100 of the Seattle Municipal Code; and adding Section 12A.20.110 to the Seattle Municipal Code.

**Summary and background of the Legislation:** This legislation increases the minimum age for buying tobacco products or vapor products from 18 to 21. Selling tobacco products or vapor products to a minor is a crime with a maximum penalty of 364 days in jail and a \$5,000 fine. This legislation also creates the crime, with a maximum penalty of 364 days in jail and a \$5,000 fine, of a marijuana store employee selling marijuana products to a person under age 21.
