1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to emergency assistance for low-income City Light Department and Seattle Public Utilities Department customers; amending Sections 21.49.042 and 21.76.065 of the Seattle Municipal Code to expand and align eligibility and assistance guidelines for emergency assistance programs.

Summary and background of the Legislation: Seattle City Light's Emergency Low-Income Assistance (ELIA) program was created in 1985. Seattle Public Utilities' Emergency Assistance Program (EAP) was created in 2006. The programs provide for a once-per-year emergency credit of 50% of an eligible customer's delinquent bills up to a maximum credit amount. For the EAP, if a minor child lives in the household, the customer may receive emergency assistance twice per calendar year. ELIA does not have a similar provision for households with minor children. Additionally, the maximum credit amount for the EAP adjusts annually to reflect the average growth in residential bills, but ELIA does not contain a similar adjustment. Both of the programs provide assistance for customers whose total household income does not exceed 70% of the Washington State median income.

This bill would align the eligibility and assistance guidelines for the EAP and ELIA assistance programs. The bill would increase the income eligibility to 80% of the state median income, and would allow application of emergency assistance toward 100% of a customer's delinquent bills. It would also add a twice-per-year provision to the ELIA program for households with minor children, and would increase ELIA's maximum credit amount on an annual basis to reflect the average growth in electric bills for residential customers. Lastly, it would allow a customer to be eligible for the credit upon notification of a ten-day disconnect notice.

Passage of this ordinance will lead to a decrease in SCL's and SPU's revenues as more customers sign up for emergency assistance. For SCL, the amounts for 2020 are rough estimates for 718 customers, with an additional included estimate for customers eligible for

two instances of ELIA assistance (per calendar year) if the household includes minor children. For SPU, the amounts for 2020 are estimates for 992 customers.
