Primary specializations: transit performance analytics, real-time passenger information, passenger-facing transit alerts.

Major projects include:

- Transit Performance Dashboard: currently developing interactive data tools to track on-time performance, travel times, and crowding on the MBTA system.
- Transit Alerts: developed, tested, and deployed new software features to a GTFS-based alerts platform that allows dispatchers to easily disseminate transit alerts across multiple mediums including third party applications (such as Transit app and Google Maps), e-mail, SMS, and passenger information signs. Alerts from IBI's transit alerts platform are viewed by thousands of passengers a day in Boston, MA and Vancouver, BC, and soon Denver, CO and Snohomish County, WA (northern Seattle/Puget Sound).
- SunRail Real-Time Predictions: developed enhancements to SunRail's real-time arrival prediction
 algorithms. Diagnosed data quality issues affecting passenger information.
- Sound Transit Sounder Real Time Information: assessed current state of Sounder commuter rail's tracking systems and the necessary steps to implement real-time arrival predictions.

Primary specializations: short term and long range planning efforts at Boeing Field/King County International Airport. Major projects include:

- Airport Master Plan: The Master Plan is a long range guiding document for future infrastructure and facility
 development. Assisted in managing aviation consultants on the project. Lead public participation efforts,
 including outreach in environmentally-sensitive areas adjacent to the airport.
- Short Term Planning: Completed the first parking utilization study for the main terminal area. Developed near-term alternatives for additional maintenance facilities and redevelopment options.

Providence: Kennedy Plaza Reconstruction: Analyzed and determined the operational requirements to transform the city's main transit center into a large public pedestrian plaza with the intention of seeking a balance between efficient transit operations and good urban design. This project was an innovation in how

- transit service planning and scheduling can support the design of quality public space. Delivered a presentation on the project to the Federal Transit Administration Region 1 (Cambridge, MA) office in 2015.
- Memphis BRT Alternatives Analysis: Nelson\Nygaard's deputy project manager. Managed the alternative analysis's tiered screening approach, analyzing each candidate corridor's potential at ridership growth, fulfilling redevelopment goals, and supporting transit use in the Memphis metropolitan area. Developed operating plans and scenarios for local bus network changes to best coordinate with candidate BRT corridors.
- Providence: Redesigning Downtown Transit: Developed long term visions for Providence's downtown transit circulation that would include high quality transit emphasis corridors, two additional transit centers, and multi-modal connections, all which would strengthen the relationship between transit and the city's redevelopment goals.
- Rhode Island Public Transit Authority Comprehensive Operational Analysis: performed data analysis of statewide bus line ridership and cost performance, developed scenarios for route and schedule changes, and budgeted operating costs. Coordinated public outreach with a major onboard survey effort. The project made bus service easy to understand, improved service for riders, and resulted in increased ridership.
