1. BILL SUMMARY

Legislation Title:

AN ORDINANCE relating to the 2018 Families, Education, Preschool, and Promise Levy; amending the levy implementation and evaluation plan adopted by Ordinance 125807 to provide for emergency childcare services; ratifying and confirming the Mayor's Civil Emergency Order – Emergency Childcare Services for Front-line Essential Workers; declaring an emergency; and establishing an immediate effective date; all by a 3/4 vote of the City Council.

Summary and background of the Legislation:

On March 27, the Mayor exercised the authority under SMC 10.02.030 and issued an emergency order authorizing contracts for emergency childcare services that prioritize services for children of essential workers and utilized funds from the Families, Education, Preschool, and Promise (FEPP) Levy to pay for those services. Consistent with direction issued by the Washington Office of Superintendent of Public Instruction's March 23, 2020 Bulletin 025-20, essential workers include healthcare workers, first responders, pharmacy workers, and grocery store workers.

This bill amends the FEPP Levy's Implementation and Evaluation Plan (I&E Plan) with an Emergency Addendum that adds a new temporary program to the I&E Plan to provide developmentally appropriate childcare services operated consistent with guidance from public health officials. The addendum limits expenditures on the childcare services to an amount equivalent to what would have been spent on the Seattle Preschool Program (SPP) and SPP Pathway Program during the emergency time period. The addendum shall only be in effect for the duration of the civil emergency.
