Budget Action Description:

This Council Budget Action would add 1 FTE Arborist and 1 FTE Housing and Zoning Inspector to the Seattle Department of Construction and Inspections (SDCI) and \$275,237 GF to fund the positions. The positions would enforce current and potential future tree regulations. Enforcement could include investigating complaints of illegal tree cutting and pro-active enforcement of tree regulations.

The fully-loaded cost of an Arborist and a Housing and Zoning Inspector in 2021 is \$123,814 and \$151,423, respectively. In 2018, SDCI resolved tree-related enforcement actions, for which there was a violation, in approximately 51 days. In 2019 and 2020, SDCI resolved tree-related enforcement actions in approximately 169 days and 147 days, respectively.
