

CITY OF SEATTLE

ORDINANCE	
COUNCIL BILL	

- AN ORDINANCE relating to residential evictions; guaranteeing the right to legal counsel regardless of ability to pay for any residential renter in Seattle responding to an unlawful detainer suit; and adding a new Section 22.206.195 to the Seattle Municipal Code.
- WHEREAS, in September 2018, the Seattle Women's Commission and the King County Bar Association jointly published *Losing Home: The Human Cost of Eviction in Seattle*, finding that households who are evicted face material hardships that make it more difficult to secure safe and affordable housing and that the most disadvantaged groups face the highest likelihood of eviction; and
- WHEREAS, the Losing Home report found that most evicted respondents became homeless, with 37.5 percent completely unsheltered, 25.0 percent living in a shelter or transitional housing, and 25.0 percent staying with family or friends. Only 12.5 percent of evicted respondents found another apartment or home to move into; and
- WHEREAS, the report also found that tenants commonly reported both mental health issues, such as stress and depression, and physical health issues, such as heart conditions, associated with their eviction; and
- WHEREAS, housing instability during childhood has been attributed to an increased likelihood of negative health and educational effects; and
- WHEREAS, evictions can lead to long-term economic impact to individuals, families, and the City; and
- WHEREAS, in 2018, the King County Medical Examiner's Office (KCMEO) investigated the deaths of 194 individuals presumed to be homeless. This represents 25 more deaths than investigated in 2017; and

WHEREAS, people experiencing homelessness have a much higher risk than the general population of

developing exposure-related conditions. The KCMEO 2018 investigation found that over half of presumed homeless deaths investigated occurred outside and that approximately 62 percent of presumed homeless deaths investigate were attributed to non-natural causes (drug overdose, accidents (including hypothermia), suicide, homicide, and undetermined); and

- WHEREAS, the Washington State Legislature has declared a state policy to help residents who are experiencing a temporary crisis in retaining stable housing to avoid eviction from their homes, as expressed in Laws of 2019 c 356 section 1; and
- WHEREAS, tenants with counsel have improved housing stability, both by staying in their residences but also by gaining additional time to relocate and access to emergency rental assistance; and
- WHEREAS, starting in 2018, the Seattle Department of Construction and Inspections has contracted with the Housing Justice Project, a program of the King County Bar Association, to provide free legal support to renters facing evictions; and
- WHEREAS, the Housing Justice Project has reported that 56 percent of renters facing unlawful detainers in 2019 prevented eviction with the support of City funded legal support, up from less than 24 percent prior to that funding; and
- WHEREAS, the Seattle City Council intends that the Seattle Department of Construction and Inspections will continue, and as needed, expand its contract with the Housing Justice Project to fulfil the commitments in this ordinance unless another attorney organization becomes better suited to accomplish this work at some future date; and
- WHEREAS, the Housing Justice Project has estimated there are 1,200 eviction court filings against individuals and families in Seattle each year; and
- WHEREAS, New York City, Newark, Boulder, Baltimore, Cleveland, Philadelphia, and San Francisco have all enacted some form of "right to counsel" legislation for renters facing eviction; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. A new Section 22.206.195 is added to the Seattle Municipal Code as follows:

22.206.195 Right to legal counsel in eviction proceedings

A. Any tenant residing in Seattle who is named in an unlawful detainer suit under chapter 59.18 RCW has the right to legal counsel free of charge as set forth in this Section 22.206.195, regardless of the person's ability to pay.

B. Legal representation through a non-City entity shall be made available to a person described in subsection 22.206.195. A upon that person's request as soon as practicable after service of a summons for an unlawful detainer suit and at least until the complaint is withdrawn, the case is dismissed, or a judgment is entered.

C. To the extent allowed by law, the Director is authorized to negotiate and execute a contract for unlawful detainer defense services provided under this Section 22.206.195 with an appropriate attorney organization that:

- 1. Has experience supporting renters advocating for their legal rights;
- 2. Has at least one location near the courtroom where eviction proceedings are heard, in the King County courthouse; and
- 3. Has the ability to provide legal service in languages commonly spoken in Seattle or has access to all necessary language translation services.
- D. The Seattle Department of Construction and Inspections shall educate renters of their right to counsel free of charge, including materials made available in languages commonly spoken by Seattle residents. Owners must provide notice to the tenant of their right to counsel in any notice required by subsection 22.206.160.C, subject to the Department's rulemaking. The Department shall adopt a rule or rules to enforce this subsection 22.206.195.D. Failure to include the required language on any notice issued pursuant to subsection 22.206.160.C shall be a defense to eviction.
 - E. Nothing in this Section 22.206.195 shall be construed to require persons served with an unlawful

detainer suit to accept counsel provided by the City. The City is not responsible for paying any legal fees associated with representation other than that authorized by the contracts described in subsection 22.206.195.C.

F. Nothing in this Section 22.206.195 is intended to require representation by an attorney that would violate the Washington State Court Rules of Professional Conduct.

Section 2. The City shall contract for attorneys for the purposes of the legal representation provided under Seattle Municipal Code Section 22.206.195 and shall allocate sufficient funding to provide such representation for any eligible person.

Section 3. The provisions of this ordinance are declared to be separate and severable. The invalidity of any clause, sentence, paragraph, subdivision, section, or portion of this ordinance, or the invalidity of its application to any person or circumstance, does not affect the validity of the remainder of this ordinance or the validity of its application to other persons or circumstances.

Section 4. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.

Legislation Title: AN ORDINANCE relating to residential evictions; guaranteeing the right to legal counsel regardless of ability to pay for any residential renter in Seattle responding to an unlawful detainer suit; and adding a new Section 22.206.195 to the Seattle Municipal Code.

Summary and background of the Legislation: The City currently funds non-profits to provide counsel to any tenant in Seattle facing eviction or who is subject to unlawful detainer. This legislation creates a right for any tenant facing eviction to have the opportunity to retain counsel. Representation by counsel can improve the outcomes in eviction court for tenants.

For 2020, the City has funded the organization currently doing this work (the Housing Justice Project) at \$218,000. Depending on the continuation of the eviction moratorium and how the courts decide to handle the evictions currently not being filed, it may be necessary to fund HJP by another \$100,000 in 2020. To make the right to counsel effective long-term, the City will need to commit ongoing funding to attorneys equipped to represent tenants. The current cost assumptions estimate that it will take \$750,000 in a typical year to provide legal counsel to any tenant facing eviction. Assuming HJP continues to receive \$318,000 in ongoing funding, they may require up to an additional \$432,000 in 2022, either by using more existing ongoing funding for right to counsel than for other tenant services or through additional appropriation for this purpose in the 2022 budget.

Tenants with counsel fare better in eviction court than when unrepresented. If the legislation does not pass, and tenants continue to show up to eviction court without representation, there is a greater likelihood of increased housing instability and the potential for homelessness.

Subject: Council Bill 120007: Right to counsel for tenants facing eviction in Seattle

On March 4, 2021, the Sustainability and Renters Rights Committee ("Committee") will discuss and possibly vote on Council Bill (CB) 120007 that would establish the right to counsel for tenants in Seattle facing eviction. This memorandum describes the bill and related fiscal considerations.

Council Bill 120007

This legislation would add a new section to the Housing Code (SMC 22.206.195) to establish that a tenant residing in Seattle and facing eviction in court (also known as an unlawful detainer suit) has a right to a lawyer. This would create that right free of charge, regardless of the person's level of income. Legal counsel would be available upon the tenant's request and as soon as practicable once the person receives a summons for the eviction proceeding. Representation would continue until the complaint is withdrawn, the court dismisses the case, or the court makes a ruling.

The bill would also authorize the Seattle Department of Construction and Inspections (SDCI) to contract with an organization of attorneys that:

- Has experience supporting renters advocating for their legal rights;
- Has at least one location near where eviction proceedings are occurring (currently in the King County Courthouse); and
- Can provide legal service in languages common to Seattle or has access to translation services.

SDCI would be required to educate tenants about their right to counsel in languages commonly spoken in Seattle. The bill would also require landlords to provide notice of this right to their tenants in any notice they are already required to provide in pursuing just cause eviction. SDCI would adopt a Director's rule to specify the language required to be include in the landlord's notice. Failure to include notice language would be a defense to eviction.

CB 120007 does not require a tenant to accept counsel for eviction defense; it would only give tenants the option of such counsel. If a tenant does not accept the counsel offered, but hires a different attorney, the City is not obligated to cover such costs. Lastly, if representing a tenant would cause an attorney to violate the Washington State Court Rules of Professional Conduct, this bill would not such require representation.

The legislation also contains a non-codified section that directs the City to contract with attorneys for this purpose and allocate sufficient funding to cover representation for any eligible tenant.

Fiscal Considerations

SDCI currently contracts with a variety of organizations to provide tenant services, which include outreach as well as legal/eviction defense. Since 2019, SDCI has contracted with the Housing Justice Project (HJP) and the Tenant Law Center to provide legal/eviction defense services, among other tenant services. HJP is a law office of the King County Bar Association that provides free legal assistance to renters at risk of eviction. The Tenant Law Center similarly provides renters legal assistance in the case of eviction but is also funded to provide other services as well as staffing to support HJP.

Based on an average 1,200 eviction cases filed a year, HJP estimates that it would cost \$750,000 annually to provide legal counsel to any tenant facing eviction. For 2021, the City awarded \$218,000 to HJP and \$340,000 to the Tenant Law Center. Because both the Washington State and City of Seattle eviction moratoria are currently in place until March 31, 2021 and may be extended, this level of funding could be sufficient for 2021. However, given the unprecedented nature of the COVID-19 pandemic and the resulting uncertainty regarding when filing evictions will be permitted again, it is possible that additional funding will be necessary in 2021 if this bill is passed. An initial estimate from HJP suggests that this could require increasing their contract award by \$100,000 in 2021. The need for additional funding in 2021 will become clearer when decisions are made about extending these moratoria (as well as the federal eviction moratorium) beyond the end of March.

To make the right to counsel effective long-term, the City will need to identify an ongoing source of funds for eviction defense services. On average, SDCI receives about \$615,000 in ongoing funding for tenant outreach, education, and eviction defense services so this will require providing additional funding for eviction defense specifically to provide at least \$750,000 on an ongoing basis for that use.

Next Steps

If the Committee recommends the legislation be passed, Full Council will likely vote on CB 120007 on March 15, 2021.



I have been a member Washington Community Action Network for 18 years. Throughout my time with WCAN, I have been involved in several major issues. One of the first issues I worked on was around food insecurity across the nation. In the early 2000's, we worked on the agricultural bill to ensure food security programs (food stamps, hot-feeding programs, food banks, and public school lunches) were adequately funded. In 2004, it passed with \$6.4 billion allocated to food security programs.

I also was involved with the push for the Affordable Care Act. I, along with my grandchild, shared our story about losing my daughter because of inadequate health care access. We held town halls, spoke with lawmakers, and met with people from other states to push for health care reform. Through our work, we were part of the ACA bill signing.

I, along with other grassroots members, raised concerns around housing in Seattle to Washington CAN, so as an organization we decided to take this on as an issue. I helped plan community meetings to talk about housing and tenant rights. I helped get people to take Washington CAN's survey about housing. I met with councilmembers and testified during hearings about several pieces of landlord-tenant legislation. I did media interviews about the legislation we were supporting.

In addition to my work with Washington CAN, I am currently a member of Seattle Housing Authority's Joint Policy Advisory Council. For four years, I was the chair of this council. As SHA residents, we provide advice on SHA policies to the Executive Director and his team. We ensure that SHA policies meet the needs of residents before the Board of Commissioners enacts them. Through my work with Washington CAN and SHA, I have the skills necessary to provide advice and insight to the Seattle City Council regarding renters' concerns.
