COUNCIL BILL _____

AN ORDINANCE appropriating money to pay certain audited claims for the week of November 23, 2020 through November 27, 2020 and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$23,825,497.35 on PeopleSoft 9.2 mechanical warrants numbered 4100395851- 4100400787 plus manual or cancellation issues for claims, E-Payables of \$49,679.70 on PeopleSoft 9.2 9100007853 - 9100007889 and Electronic Financial Transactions (EFT) in the amount of \$77,145,542.76 are presented for ratification by the City Council per RCW 42.24.180.

Section 2. Payment of the sum of \$49,733,764.50 on City General Salary Fund mechanical warrants numbered 51340782- 51340943 plus manual warrants, agencies warrants, and direct deposits numbered 480001

- 482688 representing Gross Payrolls for payroll ending date November 24, 2020 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council December 3, 2020 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.

Section 3. Any act consistent with the authority of this ordinance taken prior to its effective date is hereby ratified and confirmed.

Section 4. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
