COUNCIL BILL

AN ORDINANCE relating to land use and zoning; amending Section 23.41.010 of the Seattle Municipal Code to approve the Capitol Hill Neighborhood Design Guidelines, 2019.

WHEREAS, the Capitol Hill Neighborhood was designated as an Urban Center Village in 1999; and

WHEREAS, The City of Seattle worked with the Capitol Hill EcoDistrict and other community stakeholders to

assess recent development and identify current priority design issues in the Capitol Hill Urban Center

Village; and

WHEREAS, the Office of Planning and Community Development have engaged the Capitol Hill EcoDistrict and other community stakeholders in the development of updated Neighborhood Design Guidelines;

WHEREAS, the Office of Planning and Community Development on January 17, 2019, released the Capitol

Hill Neighborhood Design Guidelines State Environmental Policy Act (SEPA) Checklist and a

Determination of Non-Significance, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Subsection 23.41.010.B of the Seattle Municipal Code, which section was last amended by the ordinance introduced as Council Bill 119505, is amended as follows:

23.41.010 Design review guidelines
