AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$34,257,314.23 on Summit mechanical warrants numbered 4002768242 - 4002772462 plus manual or cancellation issues for claims, E-Payables of \$250,443.06 on Summit 9000026634 - 9000026712 and Electronic Financial Transactions (EFT) in the amount of \$35,135,587.12 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$43,253,972.93 on City General Salary Fund mechanical warrants numbered 51267698 - 51268443 plus manual warrants, agencies warrants, and direct deposits numbered 30001
