## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$13,055,060.84 on Summit mechanical warrants numbered 4002781755 - 4002784162 plus manual or cancellation issues for claims, E-Payables of \$63,713.07 on Summit 9000026915 - 9000026976 and Electronic Financial Transactions (EFT) in the amount of \$18,483,377.20 are presented for ratification by the City Council per Chapter RCW 42.24.180.
