COUNCIL BILL

## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$20,753,975.07 on PeopleSoft 9.2 mechanical warrants numbered 4100028815- 4100031288 plus manual or cancellation issues for claims, E-Payables of \$131,130.58 on PeopleSoft 9.2 9100000323 - 9100000365 and Electronic Financial Transactions (EFT) in the amount of \$23,931,718.61 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$45,984,551.59 on City General Salary Fund mechanical warrants numbered 51292543 - 51293189 plus manual warrants, agencies warrants, and direct deposits numbered
