AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$21,512,716.75 on PeopleSoft 9.2 mechanical warrants numbered 4100044411- 4100046526 plus manual or cancellation issues for claims, E-Payables of \$132,141.39 on PeopleSoft 9.2 9100000592 - 9100000634 and Electronic Financial Transactions (EFT) in the amount of \$90,301,944.35 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$47,250,180.93 on City General Salary Fund mechanical warrants numbered 51294340 - 51295062 plus manual warrants, agencies warrants, and direct deposits numbered

Section 4. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
