## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$22,005,314.47 on PeopleSoft 9.2 mechanical warrants numbered 4100055909- 4100057968 plus manual or cancellation issues for claims, E-Payables of \$126,499.64 on PeopleSoft 9.2 9100000796 - 9100000833 and Electronic Financial Transactions (EFT) in the amount of \$82,123,834.57 are presented for ratification by the City Council per Chapter RCW 42.24.180.
