### RESOLUTION \_\_\_\_\_

A RESOLUTION endorsing a budget and position modifications for The City of Seattle for 2020. WHEREAS, Resolution 28885 stated the City Council's intent to adopt a Citywide biennial budgeting process

consisting of two one-year budgets, effective January 1, 1995; and

WHEREAS, with the exception of continuing and carry-forward appropriations, no funds will be appropriated

for Year Two of a biennium in the first year of a biennial budget process; and

WHEREAS, Resolution 28885 states the City Council's intent to endorse a budget for Year Two of each

biennial budgeting period at the time it adopts the Year One budget; and

WHEREAS, the Mayor and City Council wish to endorse the 2020 budget and position modifications for The City of Seattle, which will be subject to further review and modification before being adopted by future ordinance in 2019; NOW, THEREFORE,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEATTLE, THE MAYOR CONCURRING, THAT:

Section 1. The Mayor and City Council endorse the appropriations for The City of Seattle's annual budget for 2020 that are reflected in Attachment A to this resolution (2020 Appropriations by Budget Control Level) as restricted by the budget provisos in Clerk File 314408.

Section 2. The Mayor and City Council endorse the position modifications for 2020 as reflected in Attachment B to this resolution.

Section 3. In 2019, the City Council intends to conduct a mid-biennium budget review and adoption process for the 2020 Budget, whereby the Mayor will submit a 2020 Proposed Budget to reflect technical corrections and adjustments to the 2020 Endorsed Budget.
