COUNCIL BILL	

AN ORDINANCE relating to land use and zoning; amending Section 23.41.010 of the Seattle Municipal Code to approve the 2019 Uptown Neighborhood Design Guidelines.

WHEREAS, the Uptown Neighborhood was designated as an Urban Center in 1994; and

WHEREAS, The City of Seattle, working with the Uptown Alliance, developed the Uptown Urban Design

Framework in 2016; and

WHEREAS, the Uptown Urban Design Framework developed neighborhood design recommendations that

anticipated substantial redevelopment in the Uptown Urban Center; and

- WHEREAS, the Seattle City Council in 2017 adopted new zoning regulations that greatly increased development capacity in the Uptown Urban Center; and
- WHEREAS, the Office of Planning and Community Development has engaged the Uptown Alliance Land Use Review Committee in the development of updated Uptown Neighborhood Design Guidelines; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Subsection 23.41.010.B of the Seattle Municipal Code, which section was last amended by the ordinance introduced as Council Bill 119362, is amended as follows:

23.41.010 Design review guidelines
