AN ORDINANCE appropriating money to pay certain audited claims for the week of November 30, 2020 through December 4, 2020 and ordering the payment thereof.

## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$28,432,661.05 on PeopleSoft 9.2 mechanical warrants numbered 4100400788- 4100405835 plus manual or cancellation issues for claims, E-Payables of \$79,542.23 on PeopleSoft 9.2 9100007890- 9100007952 and Electronic Financial Transactions (EFT) in the amount of \$76,271,266.26 are presented for ratification by the City Council per RCW 42.24.180.

Section 2. Any act consistent with the authority of this ordinance taken prior to its effective date is hereby ratified and confirmed.
