COUNCIL BILL _____

AN ORDINANCE relating to City employment; adopting a 2021 Citywide Position List.

WHEREAS, the City Council annually adopts a Citywide Position List and a City Budget; and

WHEREAS, in 2020, the City Council passed Ordinance 126180 adopting a 2020 Citywide Position List, and
Ordinance 126237 adopting the 2021 Budget; and

WHEREAS, Ordinance 126237 anticipated additional legislation from the Seattle Department of Human

Resources proposing a 2021 Citywide Position List that reflects changes to the 2020 Citywide Position

List; and

WHEREAS, Ordinance 126237 anticipated that such position list would include: modifications to the 2020

Position List for changes effected by subsection 3(a) of Ordinance 126237; the Seattle Human

Resources Director's reclassification of regular positions made from January 1, 2020 through December

31, 2020; and the creation, modification, or abrogation of regular positions by ordinances passed during

the same period; and

WHEREAS, the Seattle Department of Human Resources has duly compiled a 2021 Citywide Position List;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Effective January 1, 2021, the officer and employee positions designated in the "2021 Citywide Position List," attached to this ordinance as Exhibit A, are hereby established as the regular full-time positions and regular part-time positions in the various City departments or offices shown in each position classification (title) listed; however, if Exhibit A shows a later effective date for any such position, the later date shall govern.

Section 2. The positions included in Exhibit A shall remain in effect subject to modification by any appropriate administrative or legislative action occurring on or after January 1, 2021.

Section 3. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
