## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$16,878,175.30 on PeopleSoft 9.2 mechanical warrants numbered 4100545595 - 4100547406 plus manual or cancellation issues for claims, E-Payables of \$37,572.19 on PeopleSoft 9.2 9100011160 - 9100011192 and Electronic Financial Transactions (EFT) in the amount of \$101,258,967.63 are presented for ratification by the City Council per RCW 42.24.180.

Section 2. Payment of the sum of \$52,618,293.98 on City General Salary Fund mechanical warrants numbered 51358912 - 51359552 plus manual warrants, agencies warrants, and direct deposits numbered 60001

Section 4. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
