ORDINANCE	
COUNCIL BILL	

- AN ORDINANCE relating to land use and zoning; amending the Seattle Comprehensive Plan to incorporate changes relating to housing affordability proposed as part of the 2014-2015 Comprehensive Plan annual amendment process.
- WHEREAS, The City of Seattle (City) adopted a Comprehensive Plan through Ordinance 117221 in 1994; and
- WHEREAS, the City last amended the Comprehensive Plan through the Ordinance introduced as Council Bill 118470; and
- WHEREAS, the City has identified certain changes to be made to the Comprehensive Plan relating to housing affordability; and
- WHEREAS, these proposed amendments have been reviewed as part of a programmatic environmental review and a determination of non-significance was issued June 11, 2015, beginning a 21-day public review period of draft changes to the Comprehensive Plan relating to housing affordability; and
- WHEREAS, these amendments will be considered for adoption simultaneously in 2015 with bills containing other Comprehensive Plan amendments proposed as part of the annual amendment process and still other amendments proposed as part of the periodic review required by the Growth Management Act; and
- WHEREAS, the Council's Planning, Land Use and Urban Sustainability Committee held a public hearing on September 15, 2015; and
- WHEREAS, these proposed amendments have been reviewed and analyzed by the Department of Planning and

Development and considered by the Council; and

- WHEREAS, the City has provided for public participation in the development and review of these proposed amendments; and
- WHEREAS, the Council has reviewed and considered the Executive's report and recommendations, public testimony made at the public hearing, and other pertinent material regarding the proposed amendments; and
- WHEREAS, the Council finds that the amendments to be adopted are consistent with the Growth Management Act, and will protect and promote the health, safety, and welfare of the general public; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. The Seattle Comprehensive Plan, as last amended by the Ordinance introduced as Council Bill 118470, is amended to change the Land Use Element, Housing Element, and Neighborhood Planning Element as shown in Attachment 1, Proposed Changes to Comprehensive Plan Related to Housing Affordability.

Section 2. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
