CITY OF SEATTLE ORDINANCE

AN ORDINANCE relating to City employment; authorizing the execution of a collective bargaining agreement between The City of Seattle and the Seattle Parking Enforcement Officers' Guild; and ratifying and confirming certain prior acts.

COUNCIL BILL

- WHEREAS, the previous agreement between The City of Seattle and the Seattle Parking Enforcement Officers' Guild that established wages, hours, benefits, and other conditions of employment expired on December 31, 2014; and
- WHEREAS, employees represented by the Seattle Parking Enforcement Officers' Guild continued to work after the agreement expired on condition that the subject of their wages, hours, benefits, and other conditions of employment continue to be negotiated; and
- WHEREAS, collective bargaining has led to an agreement between The City of Seattle and the Seattle Parking Enforcement Officers' Guild; and
- WHEREAS, separate, future legislation will be forwarded by the City Budget Office to provide budget appropriation authority to cover compensation authorized in the collective bargaining agreement attached to this ordinance; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. As requested by the Seattle Human Resources Director and recommended by the Mayor, the Mayor is authorized on behalf of The City of Seattle ("City") to execute a collective bargaining agreement between the City and the Seattle Parking Enforcement Officers' Guild, substantially in the form attached to this ordinance as Attachment 1 and identified as "Agreement by and between The City Of Seattle and Seattle
