ORDINANCE _____

COUNCIL BILL

AN ORDINANCE relating to City employment, commonly referred to as the Second Quarter 2018 Employment Ordinance; designating positions as exempt from Civil Service status; and establishing new titles and salaries; all by a 2/3 vote of the City Council.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Designating five positions as exempt from Civil Service status. As recommended by the

Seattle Human Resources Director in the Classification Determination Reports specified, the following

positions are designated as exempt from Civil Service as noted below, pursuant to Seattle Municipal Code

Section 4.13.010:
