ORDINANCE	
COUNCIL BILL	

AN ORDINANCE appropriating money to pay certain claims for the week of June 20, 2022 through June 24, 2022 and ordering the payment thereof; and ratifying and confirming certain prior acts.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$10,957,525.08 on PeopleSoft 9.2 mechanical warrants numbered 4100584357 - 4100585715 plus manual or cancellation issues for claims, e-payables of \$43,051.50 on PeopleSoft 9.2 9100011962- 9100012002, and electronic financial transactions (EFT) in the amount of \$24,654,794.59 are presented to the City Council under RCW 42.24.180 and approved consistent with remaining appropriations in the current Budget as amended.

Section 2. Payment of the sum of \$53,481,008.80 on City General Salary Fund mechanical warrants numbered 51365468 - 51366279 plus manual warrants, agencies warrants, and direct deposits numbered 260001 - 262801 representing Gross Payrolls for payroll ending date June 21, 2022, as detailed in the Payroll Summary Report for claims against the City that were reported to the City Council June 30, 2022, is approved consistent with remaining appropriations in the current budget as amended.

Section 3. RCW 35.32A.090(1) states, "There shall be no orders, authorizations, allowances, contracts or payments made or attempted to be made in excess of the expenditure allowances authorized in the final budget as adopted or modified as provided in this chapter, and any such attempted excess expenditure shall be void and shall never be the foundation of a claim against the city."
