CITY OF SEATTLE

ORDINANCE

COUNCIL BILL

AN ORDINANCE authorizing, in 2022, acceptance of funding from non-City sources; authorizing the heads of the Executive Department, Department of Finance and Administrative Services, Department of Neighborhoods, Human Services Department, Seattle Parks and Recreation, Seattle Public Library, Seattle Public Utilities, and the Seattle Police Department to accept specified grants, private funding, and subsidized loans and to execute, deliver, and perform corresponding agreements; and ratifying and confirming certain prior acts.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. The Directors of the City Budget Office, Department of Finance and Administrative Services,

Department of Neighborhoods, Human Services Department, Office of Emergency Management, Office of

Immigrant and Refugee Affairs, Office of Planning and Community Development, and Office of Sustainability

and Environment, the Superintendent of Seattle Parks and Recreation, the Executive Director and Chief

Librarian of Seattle Public Library, the General Manager of Seattle Public Utilities, and the Police Chief are

authorized to accept the following non-City funding from the grantors listed below; and to execute, deliver, and

perform, on behalf of The City of Seattle, agreements for the purposes described below. The funds, when

received, shall be deposited in the receiving funds identified below to support future appropriations, or in

support of, or as reimbursement for, the corresponding appropriations set forth in the ordinance introduced as
