1. BILL SUMMARY

Legislation Title: AN ORDINANCE authorizing the Director of the Department of Finance and Administrative Services or the Director's designee to execute a lease with the Department of the Army for the City's continued use of an approximately 13,000-square-foot warehouse facility at 1561 Alaskan Way South for the operation of the St. Martin de Porres Shelter for homeless men over the age of 50; and ratifying and confirming certain prior acts.

Summary and Background of the Legislation: For over 35 years, pursuant to a lease granted by the Department of the Army, The City of Seattle ("City") has utilized an approximately 13,000-square-foot warehouse facility (located at 1561 Alaskan Way South) as a shelter for homeless men over the age of 50. The shelter, commonly known as the St. Martin de Porres Shelter, is currently operated by Catholic Community Services of Western Washington pursuant to an agreement with the City's Human Services Department ('HSD"). HSD has requested this lease extension to continue shelter operations on site.

The City's existing lease with the Department of the Army for the St. Martin de Porres Shelter will expire on July 31, 2023. The Department of the Army has offered the City a new lease, the term of which will run for five years from August 1, 2023, through July 31, 2028. The City will not pay rent for this shelter space, and the consideration for the Lease is the City's maintenance of the shelter, as outlined in Exhibit C to the lease. Pursuant to Seattle Municipal Code subsection 3.127.020.C.2, the authority of the Director of the Department of Finance and Administrative Services ("FAS") to execute leases is limited to those where the square footage of non-office premises does not exceed 9,000 square feet. Therefore, the Director of FAS now seeks the authority to execute for and on behalf of the City a new lease agreement for the St. Martin de Porres Shelter (where the square footage of the premises exceeds 9,000 square feet) with the Department of the Army.

Yes. Absent the adoption of this legislation, the City would no longer have an agreement with the Department of the Army for the use of premises out of which the St. Martin de Porres shelter is operated. Absent such an agreement, the continued operation of the shelter would be in jeopardy.

Yes. Adoption of this legislation would permit the City's Human Services Department to continue its arrangement with Catholic Community Services of Washington ("CCS"). Under this agreement, CCS will, at least in the near-term, continue to operate the shelter.

This legislation does not modify any material item that would be visible to the general public or necessitate public communications. Any delay in implementing the legislation may affect the ability of HSD to keep this longstanding shelter open and also detrimentally impact the City's homelessness response to the clients of the shelter, all of whom are vulnerable older male adults, many from historically disadvantaged communities.
