### 1. BILL SUMMARY

- a. **Legislation Title:** AN ORDINANCE relating to residential rental properties; amending Sections 7.24.060, 7.24.070 and 7.24.080 of the Seattle Municipal Code; requiring that landlords provide information to tenants about how to register to vote and how to update voter registration information.
- b. **Summary and background of the Legislation:** Currently, landlords are required to give tenants and prospective tenants a summary, prepared by the Seattle Department of Construction and Inspections (SDCI), that provides information on the state and City landlord tenant laws. This legislation will require that SDCI include information about how to register to vote or update voter registration information in these summaries and landlords will be required to provide this information to tenants.

Studies have shown that voter turnout is lower among people who have recently moved. Providing information to tenants at the time they are entering a new rental agreement may increase voter participation among tenants who have recently relocated.
