1. BILL SUMMARY

Legislation Title: AN ORDINANCE amending Ordinance 127156, which adopted the 2025 Budget; making appropriations from the General Fund for food programs and reserves; and ratifying and confirming certain prior acts; all by a 3/4 vote of the City Council.

Summary and Background of the Legislation: On October 1, 2025, the U.S. federal government ‘shut down’ as a result of a lack of appropriations to federal agencies, including the U.S. Department of Agriculture (USDA), which administers the Supplemental Nutritional Assistance Program (SNAP). SNAP provides vital food assistance to tens of millions of Americans, including tens of thousands of Seattle residents.

This legislation supports the Civil Emergency declared by Mayor Bruce A. Harrell on October 30, 2025 and authorizes \$3 million of spending to help fill the gap left by disappearing SNAP benefits. This action will allow the City to mitigate the impacts of the federal shutdown.

This bill appropriates a total of \$3 million from the General Fund to support the emergency spending by two City departments (the Human Services Department and Office of Sustainability and Environment).

This bill also appropriates \$1 million from the GF to Finance General to create a reserve to mitigate the impact of federal funding reductions or federal policy changes on City and community provided programs. Unspent portions of this appropriation will carry forward into future years until fully spent or abandoned by ordinance. This is in addition to the \$1.06 million appropriated for this purpose in ORD 127362, the 2026 Adopted Budget.

Cash to support the appropriations in this bill was set-aside in non-appropriated reserves as part of the 2026 balanced GF budget.
