ORDINANCE 124950

COUNCIL BILL 118577

AN ORDINANCE relating to the City's traffic code; amending Sections 11.14.055, 11.14.184, 11.23.380, 11.23.400, 11.31.020, 11.34.020, 11.56.020, 11.56.025, 11.56.320, 11.56.350, 11.56.355, 11.57.310, 11.72.065, and 11.84.380 of the Seattle Municipal Code, adding Section 11.58.435 to the Seattle Municipal Code, and repealing Section 11.14.185 of the Seattle Municipal Code to conform the Seattle Municipal Code with changes in state law and make technical corrections.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Section 11.14.055 of the Seattle Municipal Code, enacted by Ordinance 108200, is amended as follows:

11.14.055 Bicycle and Electric-assisted bicycle ((-))

A. "Bicycle" means every device propelled solely by human power upon which a person or persons may ride, having ((with)) two tandem (((2 or more))) wheels either ((-)) of which is ((not more than one (1) wheel shall be less than sixteen (-))16(()) inches or more in diameter, or three wheels, any one of which is more than 20 inches in diameter ((having a steering device and saddle or seat or seats, and propelled solely by human power)).

B. "Electric-assisted bicycle" means a bicycle with two or three wheels, a saddle, fully operative pedals for human propulsion, and an electric motor. The electric-assisted bicycle's electric motor must have a power output of no more than 1000 watts, be incapable of propelling the device at a speed of more than 20 miles per hour on level ground, and be incapable of further increasing the speed of the device when human power alone is used to propel the device beyond 20 miles per hour.

Section 2. Section 11.14.184 of the Seattle Municipal Code, enacted by Ordinance 121518, is renumbered 11.14.186 and further amended to read as follows:

((11.14.184)) 11.14.186 EPAMD (Electric personal assistive mobility device) ((-))

1 "EPAMD" means:

2 A. an electric personal assistive mobility device, which is a self-balancing device with two
3 wheels not in tandem, designed to transport only one person by an electric propulsion system with an
4 average power of ~~((seven hundred fifty))~~ 750 watts ~~((one))~~ 1 horsepower) having a maximum speed on
5 a paved level surface, when powered solely by such a propulsion system while ridden by an operator
6 weighing one hundred seventy pounds, of less than ~~((twenty))~~ 20 miles per hour; or

7 B. a self-balancing device with one wheel designed to transport only one person by an electric
8 propulsion system with an average power of 2000 watts (2 2/3 horsepower) having a maximum speed on
9 a paved level surface, when powered solely by such a propulsion system, of less than 20 miles per hour.

11 Section 3. Section 11.23.380 of the Seattle Municipal Code, last amended by Ordinance 121678,
12 is amended as follows:

13 **11.23.380 Disabled person's parking privilege ((-))**

14 A. A person who has obtained a ~~((with a current and valid identification card and disabled))~~
15 parking placard or special license plate under RCW 46.19.010 and RCW 46.19.030 ~~((from the~~
16 Washington State Department of Licensing under RCW 46.16.381)) shall be allowed to park a vehicle
17 displaying the placard or plate that is being used to transport the holder of such special parking
18 privileges ~~((such person))~~ free of charge for a maximum of a four-hour time period in parking areas,
19 including those with a parking payment device, that are otherwise restricted as to the length of time
20 parking is permitted. Areas with four-hour time limits shall be appropriately signed and/or marked.

21 B. ~~((A person with a current and valid identification card and disabled parking license plate or~~
22 disabled parking year tab from the Washington State Department of Licensing under RCW 46.16.381
23 shall be allowed to park the vehicle displaying the license plate or year tab that is being used to transport
24 the holder of such special parking privileges free of charge for a maximum of a four-hour time period in parking areas,
25 including those with a parking payment device, that are otherwise restricted as to the length of time

1 the person free of charge for unlimited periods of time in parking areas, including those with parking
2 payment devices, that are otherwise restricted as to the length of time parking is permitted.

3 ~~C. This section~~) Subsection 11.23.380.A shall have no application to those zones or areas in
4 which the stopping, parking, or standing of all vehicles is prohibited or which are reserved for special
5 types of vehicles. ~~((Such person shall not be permitted the foregoing privilege unless he or she obtains
6 and displays a placard, disabled parking year tab, or license plate issued pursuant to RCW 46.16.381.
7 (RCW 46.16.381)))~~

8 Section 4. Section 11.23.400 of the Seattle Municipal Code, as last amended by Ordinance
9 123632, is amended as follows:

10 **11.23.400 Disabled parking - Enforcement ((-))**

11 A. Knowingly providing false information in conjunction with an application for ~~((a disabled
12 parking permit))~~ special parking privileges for persons with disabilities is a gross misdemeanor. For
13 purposes of this subsection 11.23.400.A, "knowingly" has the same meaning as in Section
14 12A.04.030.B.

15 B. Except as provided by subsection 11.23.400.A ~~((of this section))~~, it is a ~~((traffic infraction,
16 with a monetary penalty of Two Hundred Fifty Dollars (\$250),))~~ misdemeanor for any person willfully
17 to obtain a ~~((disabled parking placard,))~~ special license plate, ((license)) placard, special year tab, or
18 ~~((photo))~~ identification card in a manner other than that established by chapter 46.19 RCW ~~((Chapter
19 46.19))~~.

20 C. It is a misdemeanor for any person to sell a placard, special license plate, special year tab, or
21 identification card issued under chapter 46.19 RCW.

22 D. The unauthorized use of a ~~((disabled))~~ parking placard, special license plate, special year
23 ~~((license))~~ tab, or ~~((photo))~~ identification card issued under chapter 46.19 RCW ~~((Chapter 46.19))~~ is a
24
25

1 parking infraction with a monetary penalty of ~~((Two Hundred Fifty Dollars (€))\$250((€)))~~. In addition to
2 any penalty or fine imposed under this subsection 11.23.400.D, ~~((Two Hundred Dollars (€))\$200((€)))~~
3 shall be assessed, which assessment shall be allocated as provided by RCW 46.19.050. For the purpose
4 of this subsection 11.23.400.D, “unauthorized use” includes (1) any use of a parking placard, special
5 license plate, special year tab, or identification card that is expired, inactivated, faked, forged, or
6 counterfeited, (2) any use of a parking placard, special license plate, special year tab, or identification
7 card of another holder if the initial holder is no longer eligible to use or receive it, and (3) any use of a
8 parking placard, special license plate, special year tab, or identification card of another holder even if
9 permitted to do so by the holder. Any reduction in any penalty ~~((or fine))~~ and assessment imposed under
10 this subsection 11.23.400.D shall be applied proportionally between the penalty ~~((or fine))~~ and the
11 assessment.

12
13 ~~((D.))~~ E. The court may not suspend more than ~~((one-half 1/2))~~ half of any fine imposed under
14 subsection 11.23.400.D ~~((B or C of this section))~~. For a second or subsequent violation of ~~((subsection B~~
15 ~~or C of))~~ this ~~((section))~~ Section 11.23.400, in addition to a monetary penalty, a violator must complete a
16 minimum of ~~((forty (€))40((€)))~~ hours of either community service for a nonprofit organization that serves
17 the disabled community or persons having disabling diseases or any other community service that may
18 sensitize the violator to the needs and obstacles faced by persons who have disabilities.

19 ~~((E.))~~ F. Any peace officer or parking enforcement officer ~~((finding any unauthorized use of such~~
20 ~~placard or license plate shall issue and affix a notice indicating the unauthorized uses thereof in the form~~
21 ~~and in the manner required by Section 11.31.030))~~ investigating the possibility of a violation of this
22 Section 11.23.400 may request a person to show the person’s identification card or special parking
23 placard and, if such request is refused, may issue a notice of infraction for violation of this Section
24 11.23.400.

1 G. If a person is found to have violated the special parking privileges provided in this Section
2 11.23.400, and unless an appeal of that finding is pending, the court may order that the person surrender
3 a placard, special license plate, special year tab, or identification card issued under chapter 46.19 RCW.

4 Section 5. Subsection 11.31.020.A of the Seattle Municipal Code, which section was last
5 amended by Ordinance 123946, is amended as follows:

6 **11.31.020 Notice of traffic infraction – Issuance.**

7 A. A peace officer has the authority to issue a notice of traffic infraction:

- 8 1. when the infraction is committed in the officer's presence;
9 2. if an officer investigating at the scene of a motor vehicle accident has reasonable cause
10 to believe that the driver of a motor vehicle involved in the accident has committed a traffic infraction;

11 or

- 12 3. when a violation of ~~((SMC))~~ Section 11.50.140, ~~((SMC))~~ 11.50.150, ~~((SMC))~~
13 11.52.040, or ~~((SMC))~~ 11.52.100 is detected through the use of an automated traffic safety camera as
14 authorized pursuant to RCW 46.63.170 and Section ~~((11.50.560))~~ 11.50.570.

17 Section 6. Subsection 11.34.020.B of the Seattle Municipal Code, which section was last
18 amended by Ordinance 124686, is amended as follows:

19 **11.34.020 Penalties for criminal offenses**

20 * * *

21 B. Any person convicted of any of the following offenses may be punished by a fine in any sum
22 not to exceed \$1,000 or by imprisonment for a term not to exceed 90 days, or by both such fine and
23 imprisonment:

1 1. Section 11.20.010, Driver's license required—Exception—Penalty, unless the person
2 cited for the violation provided the citing officer with an expired driver's license or other valid
3 identifying documentation under RCW 46.20.035 at the time of the stop and was not in violation of
4 Section 11.56.320 or Section 11.56.340, in which case the violation is an infraction;

5 2. Section 11.20.100, Display of nonvalid driver's license;

6 3. Section 11.20.120, Loaning driver's license;

7 4. Section 11.20.140, Displaying the driver's license of another;

8 5. Section 11.20.160, Unlawful use of driver's license;

9 6. Section 11.20.200, Unlawful to allow unauthorized person to drive;

10 7. Subsection 11.20.350.C, Providing false evidence of financial responsibility;

11 8. Section 11.22.025, Transfer of ownership;

12 9. Subsection 11.23.400.B, Unlawfully obtaining placard or special license plate;

13 10. Subsection 11.23.400.C, Unlawful sale of placard or special license plate;

14 11. Section 11.32.160, Cancellation of citation;

15 ~~((10.))~~ 12. Section 11.40.180, Standard of care for drivers of motor vehicles – blind
16 pedestrians carrying white cane or using guide dog;

17 ~~((11.))~~ 13. Section 11.40.430, Prohibited entry to no admittance area;

18 ~~((12.))~~ 14. Subsection 11.56.320.D, Driving while license is suspended or revoked in the
19 third degree;

20 ~~((13.))~~ 15. Section 11.56.430, Hit and run (unattended vehicle)—Duty in case of accident
21 with unattended vehicle;

22 ~~((14.))~~ 16. Section 11.56.440, Hit and run (property damage)—Duty in case of accident
23 with property;

- ~~((15.))~~ 17. Subsection 11.58.005.A, Negligent driving in the first degree;
- ~~((16.))~~ 18. Section 11.58.190, Leaving minor children in unattended vehicle;
- ~~((17.))~~ 19. Section 11.59.010, Obedience to peace officers, flaggers, and firefighters;
- ~~((18.))~~ 20. Section 11.59.040, Refusal to give information to or cooperate with officer;
- ~~((19.))~~ 21. Section 11.59.060, Refusal to stop;
- ~~((20.))~~ 22. Section 11.59.080, Examination of equipment;
- ~~((21.))~~ 23. Section 11.59.090, Duty to obey peace officer—Traffic infraction;
- ~~((22.))~~ 24. Section 11.66.240, Obstructing or delaying train;
- ~~((23.))~~ 25. Subsection 11.74.160.C, Failure to secure load in the second degree;
- ~~((24.))~~ 26. Subsection 11.84.370.C, Possessing signal preemption device except as authorized;
- ~~((25.))~~ 27. Section 11.34.040, Aiding and abetting with respect to the criminal offenses in this subsection 11.34.020.B.

Section 7. Subsections 11.56.020.C and 11.56.020.D of the Seattle Municipal Code, which section was last amended by Ordinance 124302, are amended as follows:

11.56.020 Persons under the influence of intoxicating liquor, marijuana, or any other drug.

* * *

C. Minor Driving Or Being In Actual Physical Control Of A Motor Vehicle After Consuming Alcohol.

1. Notwithstanding any other provision of this ~~((title))~~ Title 11, a person is guilty of minor driving or being in actual physical control of a motor vehicle after consuming alcohol or marijuana if the person:

- a. Operates or is in actual physical control of a motor vehicle in the City;

1 b. Is under the age of ~~((twenty-one-))~~21~~((9))~~; and

2 c. Has, within two ~~((2))~~ hours after operating or being in actual physical control
3 of the motor vehicle, either an alcohol concentration of at least 0.02 but less than 0.08, as shown by an
4 analysis of the person's breath or blood made under RCW 46.61.506; or a THC concentration above 0.00
5 but less than the concentration specified in subsection 11.56.020.A.1.b ~~((of this section))~~, as shown
6 by analysis of the person's blood made under RCW 46.61.506.

7 2. It is an affirmative defense to a violation of this subsection 11.56.020.C, which the
8 defendant must prove by a preponderance of the evidence, that the defendant consumed a sufficient
9 quantity of alcohol or marijuana after the time of driving or being in actual physical control of the
10 vehicle and before the administration of an analysis of the person's breath or blood to cause the
11 defendant's alcohol or THC concentration to be in violation of subsection 11.56.020.C.1 ~~((of this
12 section))~~ within two ~~((2))~~ hours after driving or being in actual physical control of the vehicle. The
13 court shall not admit evidence of this defense unless the defendant notifies the prosecution prior to the
14 earlier of (a) seven ~~((7))~~ days prior to trial; or (b) the omnibus or pretrial hearing in the case of the
15 defendant's intent to assert the affirmative defense.
16

17 3. No person may be convicted under this subsection 11.56.020.C for being in physical
18 control of a motor vehicle if, prior to being pursued by a law enforcement officer, the person has moved
19 the vehicle safely off the roadway.

20 4. Analysis of blood or breath samples obtained more than two ~~((2))~~ hours after the
21 alleged driving or being in actual physical control of the vehicle may be used as evidence that within
22 two ~~((2))~~ hours after the alleged driving or being in actual physical control of the vehicle a person had
23 an alcohol or THC concentration in violation of this subsection 11.56.020.C.
24
25

1 ((4.)) 5. Minor driving or being in actual physical control of a motor vehicle after
2 consuming alcohol is a misdemeanor.

3 D. Mandatory Appearance After Charging and Conditions of Release.

4 1. A defendant who is charged with a violation of this ((~~section~~)) Section 11.56.020 shall
5 be required to appear in person before a judicial officer within one ((~~1~~)) judicial day after the arrest if
6 the defendant is served with a citation or complaint at the time of the arrest. The Municipal Court may
7 by local court rule waive the requirement for an appearance within one ((~~1~~)) judicial day if it provides
8 for the appearance at the earliest practicable day following arrest and establishes the method for
9 identifying that day in the rule.

10 2. A defendant who is charged with a violation of this ((~~section~~)) 11.56.020 and who is
11 not served with a citation or complaint at the time of the incident shall appear in court for arraignment in
12 person as soon as practicable, but in no event later than ((~~fourteen~~)) 14 days after the next day on
13 which court is in session following the issuance of the citation or the filing of the complaint or
14 information.

15 3. At the time of an appearance required by this subsection 11.56.020.D, the court shall
16 determine the necessity of imposing conditions of pretrial release according to the procedures
17 established by court rule for a preliminary appearance or an arraignment. If electronic monitoring or
18 alcohol abstinence monitoring is ordered, the court shall specify who shall provide the monitoring
19 services, and the terms under which the monitoring shall be performed. Upon conviction, the court may
20 require as a condition of the sentence that the defendant reimburse the providing agency for the costs of
21 the electronic monitoring or abstinence monitoring.

22 4. Appearances required by this subsection 11.56.020.D are mandatory and may not be
23 waived.
24

1 5. Failure of the court to comply with the requirements of this subsection 11.56.020.D
2 shall not be grounds for dismissal of any charge under this ~~((section))~~ Section 11.56.020 nor the
3 establishment of a constructive date of arraignment for purposes of Criminal Rule for Courts of Limited
4 Jurisdiction 3.3.

5 6.

6 a. When any person charged with ~~((or arrested for))~~ a violation of subsection
7 11.56.020.A or 11.56.020.B ~~((of this section))~~, in which the person has a prior offense as defined in
8 RCW 46.61.5055 and the current offense involves alcohol, is released from custody at ~~((before))~~
9 arraignment or trial on bail or personal recognizance, the Municipal Court shall require, as a condition of
10 release, that the person comply with one of the following four requirements:

11 (i) have a functioning ignition interlock device installed on all motor
12 vehicles operated by the person, with proof of installation filed with the court by the person or the
13 certified interlock provider within five ~~((5))~~ business days of the date of release from custody or as
14 soon thereafter as determined by the court based on availability within the jurisdiction; or

15 (ii) comply with 24/7 sobriety program monitoring, as defined in ~~((Laws~~
16 ~~of 2013, 2nd Sp. Sess., chapter 35, section 26; or both.))~~ RCW 36.28A.330;

17 (iii) have an ignition interlock device on all motor vehicles operated by the
18 person pursuant to subsection 11.56.020.D.6.a.(i) and submit to either 24/7 sobriety program monitoring
19 pursuant to subsection 11.56.020.D.6.a.(ii), if available, or alcohol monitoring, at the expense of the
20 person, as provided in subsection 11.56.025.L ; or

21 (iv) have an ignition interlock device on all motor vehicles operated by the
22 person and agree not to operate any motor vehicle without an ignition interlock device as required by the
23 court. Under this subsection 11.56.020.D.6.1.a.(iv), the person must file a sworn statement with the
24

1 court upon release at arraignment that states the person will not operate any motor vehicle without an
2 ignition interlock device while the ignition interlock restriction is imposed by the court. Such person
3 must also submit to either 24/7 sobriety program monitoring pursuant to subsection 11.56.020.D.6.a.(ii),
4 if available, or alcohol monitoring, at the expense of the person, as provided in subsection 11.56.025.L.

5 b. The court shall immediately notify the Washington Department of Licensing
6 when an ignition interlock restriction is imposed as a condition of release pursuant to subsection
7 11.56.020.D.6.a or where a person is charged with, or convicted of, a violation of subsection
8 11.56.020.A or 11.56.020.B and the offense involves alcohol.

9 ((b)) c. Upon acquittal or dismissal of all pending or current charges relating to a
10 violation of subsection 11.56.020.A or 11.56.020.B ((of this section)), the court shall authorize removal
11 of the ignition interlock device and lift any requirement to comply with electronic alcohol/drug
12 monitoring imposed under this subsection 11.56.020.D. Nothing in this ((section)) Section 11.56.020
13 limits the authority of the court under Section 11.20.230.

14 d. If the court authorizes removal of an ignition interlock device imposed under
15 subsection 11.56.020.D.6.a the court shall immediately notify the Washington Department of Licensing
16 regarding the lifting of the ignition interlock restriction. When an ignition interlock restriction imposed
17 as a condition of release is canceled, the court shall provide a defendant with a written order confirming
18 release of the restriction. The written order shall serve as proof of release of the restriction until the
19 Washington Department of Licensing updates the driving record.

20
21 Section 8. Subsection 11.56.025.I of the Seattle Municipal Code, which section was last
22 amended by Ordinance 124302, is amended as follows:

23 **11.56.025 Penalty for persons under the influence of intoxicating liquor or any drug.**

24 * * *

1 I. In addition to any nonsuspendable and nondeferrable jail sentence required by this subsection
2 11.56.025.I, whenever the court imposes less than ~~((three hundred sixty-four ()))~~364((~~3~~)) days in jail, the
3 court shall also suspend but shall not defer a period of confinement for a period not exceeding five
4 ~~((5))~~ years. The court shall impose conditions of probation that include: (1) not driving a motor vehicle
5 within this state without a valid license to drive; (2) not driving a motor vehicle within this state without
6 ~~((and))~~ proof of liability insurance or other financial responsibility for the future pursuant to Section
7 11.20.340; ~~((2))~~ (3) not driving or being in physical control of a motor vehicle within this state while
8 having an alcohol concentration of 0.08 or more or a THC concentration of 5.00 nanograms per milliliter
9 of whole blood or higher within two ~~((2))~~ hours after driving or being in physical control; ~~((and 3))~~
10 (4) not refusing to submit to a breath or blood test ~~((of his or her breath or blood))~~ to determine alcohol
11 or drug concentration upon request of a law enforcement officer who has probable cause to believe the
12 person was driving or was in actual physical control of a motor vehicle within this state while under the
13 influence of intoxicating liquor or drug; (5) not driving a motor vehicle in this state without a
14 functioning ignition interlock device as required by the Washington Department of Licensing. For each
15 violation of mandatory conditions of probation (1), (2), ~~((~~3~~))~~ (3), (4), or (5) of this subsection
16 11.56.025.I, the court shall order the convicted person to be confined for ~~((thirty ()))~~30((~~3~~)) days, which
17 shall not be suspended or deferred. For each incident involving a violation of a mandatory condition of
18 probation imposed under this subsection 11.56.025.I, the court shall suspend the person's license,
19 permit, or privilege to drive for ~~((thirty ()))~~30((~~3~~)) days or, if the person's license, permit, or privilege to
20 drive already is suspended, revoked, or denied at the time the finding of probation violation is made,
21 then the suspension, revocation, or denial then in effect shall be extended by ~~((thirty ()))~~30((~~3~~)) days. The

17 3. To place marijuana in a container specifically labeled by the manufacturer of the
18 container as containing a nonmarijuana substance and to then violate subsection 11.58.435.A.1.

19 B. There is a rebuttable presumption that it is a traffic infraction if the original container of
20 marijuana is incorrectly labeled and there is a subsequent violation of subsection 11.58.435.A.1.

21 C. As used in this Section 11.58.435, "marijuana" means all parts of the plant *Cannabis*, whether
22 growing or not; the seeds thereof; the resin extracted from any part of the plant; and every compound,
23 manufacture, salt, derivative, mixture, or preparation of the plant, its seeds, or resin. The term does not

1 include the mature stalks of the plant, fiber produced from the stalks, oil, or cake made from the seeds of
2 the plant, any other compound, manufacture, salt, derivative, mixture, or preparation of the mature
3 stalks, except the resin extracted therefrom, fiber, oil, or cake, or the sterilized seed of the plant that is
4 incapable of germination.

5 Section 14. Section 11.72.065 of the Seattle Municipal Code, last amended by Ordinance
6 123632, is amended as follows:

7 **11.72.065 Disabled parking, ~~((Invalid Placard - Violation.))~~ invalid placard - Violation**

8 A. A parking space or stall for a person with a disability shall be indicated by a vertical sign with
9 the international symbol of access, whose colors are white on a blue background, described under RCW
10 70.92.120, and a warning that other vehicles without permits will be impounded.

11 B. Any ~~((vehicle displaying a valid disabled parking placard that is being used to transport a))~~
12 person who meets the criteria for special parking privileges under RCW 46.19.010 shall be allowed to
13 park a vehicle being used to transport the holder of such special parking privileges free of charge for a

15 payment devices) ~~((which))~~ that are otherwise restricted as to the length of time parking is permitted.

16 Areas with four-hour time limits shall be appropriately signed and/or marked. ~~((Any vehicle displaying a
17 valid disabled license plate or valid disabled parking year tab shall be allowed to be parked free of
18 charge for unlimited periods of time in parking areas (including areas with parking payment devices)
19 which are otherwise restricted as to the length of time parking is permitted.))~~ This ~~((section))~~ subsection
20 11.72.065.B does not apply to those zones or areas in which the stopping, parking, or standing of all
21 vehicles is prohibited or which are reserved for special types of vehicles.

22 C. It is a parking infraction, with a monetary penalty of ~~((Two Hundred Fifty Dollars ()))~~ \$250 ~~(())~~
23 for any person to stop, stand, or park a vehicle in a parking space or stall provided on private property
24

1 without charge or on public property reserved for persons with physical disabilities without ((a
2 physically disabled person, whether the stall is indicated as required by subsection A of this section, by
3 pavement markings or a sign indicating that the stall is reserved for disabled parking, for any purpose or
4 length of time unless such vehicle displays)) a ((special)) placard or special license plate issued under

5 chapter 46.19 RCW ((Chapter 46.19)). In addition to any penalty or fine imposed under this subsection
6 11.72.065.C, ((Two Hundred Dollars -))\$200(()) shall be assessed. If a person is charged with a
7 violation, the person shall not be determined to have committed an infraction if the person ((produces in
8 court or before the court appearance the)) establishes that the person operating the vehicle or being
9 transported at the time of the infraction had a valid placard, special license plate or ((placard required
10 under this section)) special year tab issued under chapter 46.19 RCW. Such person must sign a statement
11 under penalty of perjury that the placard, special license plate, or special year tab produced prior to the
12 court appearance was valid at the time of infraction and issued as required under chapter 46.19 RCW.

14 D. It is a parking infraction, with a monetary penalty of ((Two Hundred Fifty Dollars
15 -))\$250(()), for any person to stop, stand, park in, block, or otherwise make inaccessible the access aisle
16 located next to a space reserved for ((physically disabled)) persons with physical disabilities. In addition
17 to any penalty or fine imposed under this subsection 11.72.065.D, ((Two Hundred Dollars -))\$200(())
18 shall be assessed.

19 E. ((The use or display of a disabled placard or license plate that is stolen, expired, issued to a
20 person who is now deceased, or is otherwise invalid in or upon a vehicle parked in a public right-of-way
21 or on other publicly owned or controlled property is a parking infraction with a monetary penalty of
22 Two Hundred Fifty Dollars (\$250).)) It is a parking infraction, with a monetary penalty of \$250, to fail
23 to fully display a placard or special license plate issued under chapter 46.19 RCW while parked on
24 private property without charge, while parked on public property reserved for persons with physical
25

1 disabilities or while parking free of charge as allowed under subsection 11.72.065.B. In addition to any
2 penalty or fine imposed under this subsection 11.72.065.D, \$200 must be assessed, for a total of \$450.
3 For the purpose of this subsection 11.72.065.D, “fully display” means hanging or placing the placard or
4 special license plate so that the full face of the placard or license plate is visible, including the serial
5 number and expiration date of the placard or license plate. If a person is charged with a violation of this
6 subsection 11.72.065.D, that person will not be determined to have committed an infraction if the person
7 produces in court or before the court appearance a valid identification card issued to that person under
8 RCW 46.19.010.

10 F. The court may not suspend more than ~~((one-half (1/2)))~~ half of any fine imposed under
11 ~~((subsection C or D of))~~ this ~~((section))~~ Section 11.72.065. For a second or subsequent violation of
12 ~~((subsection C or D of))~~ this ~~((section))~~ Section 11.72.065, in addition to a monetary penalty, a violator

14 organization that serves the disabled community or persons having disabling diseases or any other
15 community service that may sensitize the violator to the needs and obstacles faced by persons who have

18 shall be allocated as provided by RCW 46.19.050. Any reduction in any penalty ~~((or fine))~~ and

20 proportionally between the penalty ~~((or fine))~~ and the assessment.

21 Section 15. Section 11.84.380 of the Seattle Municipal Code, enacted by Ordinance 108200, is
