## **Session snapshot**

- 1,904 bills introduced
- 423 bills passed
- 795 bills tracked by OIR
- 1 Mayor lobby day
- 2 city council lobby days attended by 5 councilmembers
- 3 council members testified
- 13 departments testified at 34 different hearings



# **Public Safety**

- HB 1112 (Farivar) Removing the city residency requirement for judges pro tempore in municipalities with a population of more than 400,000 inhabitants.
- HB 2015 (Entenman) Public safety funding
  - \$100m Local Law Enforcement Grant Program administered by the CJTC
  - Authorizes a new local councilmanic (until June 2028) 0.1% sales and use tax for criminal justice purposes for cities and counties.
- SB 5595 (Alvarado) Shared streets
  - Allows cities to designate shared streets where pedestrians, bicyclists, and vehicular traffic share a portion or all of the same street.
  - Allows cities to establish a 10 mph maximum speed limit on a shared street.
- \$5 million to SDOT for Aurora Avenue safety improvements



### **Economic Development & Small Business**

- HB 1515 (Reed) Modernizing outdoor dining and special event alcohol regulation.
  - Allows exemptions from certain outdoor dining regulations such as shared use and fence requirements.
  - Allows walkaround alcohol service for special events at Seattle Center.
  - Expires December 31, 2027
- HB 1733 (Thomas) Increases the reimbursement cap from \$50,000 to \$200,000 for small business and nonprofit relocations caused by agency displacements.
- \$300,000 to OED for technology business start up incubator leasing costs.

## **Housing & Homelessness**

- HB 1403 (Taylor) Simplifying condominium construction statutes.
- HB 1516 (Hill) Conducting a study of insurance coverage options for permanently affordable homeownership units.
- HB 1774 (Fey) Allows WSDOT to lease land for less than fair market value when used for community purposes.
  - "Community purpose" defined as serving a housing, housing assistance, shelter program, park, enhanced public space, public recreation, salmon habitat restoration, or public transportation public benefit purpose.
- \$10 million in Connecting Housing to Infrastructure (CHIP) funding for Fort Lawton Redevelopment this biennium and \$10 million in CHIP pledged for the 2027-2029 biennium

### **Climate & Environment**

- SB 5284 (Lovelett) Recycling Reform Act shifts the financial responsibility for recycling to the companies that produce packaging materials, a model known as Extended Producer Responsibility (EPR), reducing utility bills for ratepayers.
- HB 1253 (Ybarra) Expanding the ability of consumer-owned utilities to enter into joint use agreements for electric generation, renewable energy facilities, or energy storage facilities.
- HB 1409 (Fitzgibbon) Clean fuels program improvements by amending the carbon intensity reduction requirements for transportation fuels and requiring the Department of Ecology to publish analysis and forecasts of CFP credit markets.

#### Climate & Environment

- \$500,000 for SPR Hutchinson Park Renovation & \$1m for Hutchinson Playfield and Court Renovation
- \$500,000 for SPR Lake City Natural Area
- \$5.7m for SPU Lower Duwamish Waterway Superfund Site Remedial Action Grant
- \$1.4m for SCL Lower Duwamish Waterway Superfund Site Remedial Action Grant

### **Adequate Services**

- SB 5509 (Alvarado) Requires cities to allow childcare centers as outright permitted uses in all zones except industrial zones, light industrial zones, and open space zones.
- HB 1314 (Callan) Lessens the burden of costs on childcare providers by amending competitive criteria for project selection for Early Learning Facilities Program funding
- HB 1648 (Dent) Addresses barriers in the childcare workforce and helps childcare businesses by improving access to training and extending timelines to complete provider qualification requirements.
- SB 5192 (Nobles) Increases funding and provides more flexibility for district materials, supplies, and operating costs (MSOC).
- SB 5263 (Pedersen) Eliminates the special education funding cap and increases funding for districts for special education.



## Seattle priority bills that did not advance

- HB 1228 (Hackney) Concerning toxicology testing by certified or accredited laboratories.
- HB 1423 (Donaghy) Authorizing the use of automated vehicle noise enforcement cameras in vehicle-racing camera enforcement zones.
- HB 1816 (Scott) Civilian crisis response teams
- SB 5052 (Salomon) Law enforcement juvenile contact
- SB 5098 (Valdez) Restricting the possession of weapons on the premises of state or local public buildings, parks or playground facilities where children are likely to be present, and county fairs and county fair facilities.
- SB 5798/HB 2049 (Pedersen/Bergquist) Property tax reform



## **Operating Budget Revenue**

- Excise tax on sale of Zero Emission Vehicle program credits (HB 2077)
- Estate tax increase (SB 5813)
  - Increases exempt amount from \$2.1m to \$3m
- Capital gains tax increase (SB 5813)
  - Additional 2.9% for gains above \$1m

## **Operating Budget Revenue**

- Establishing sales tax on currently exempt services (SB 5814)
  - Services include, computer and IT, temporary staffing, advertising, investigation and security, live presentations, and data processing.
  - Adds nicotine to the tobacco tax
- B&O tax increase (SB 2081)
  - Primary B&O rates on gross proceeds increased from 0.471% and 0.484% to 0.5%.
  - Services and other activities rate for businesses with gross income of more than \$5m increased from 1.75% to 2.1%
  - 0.5% surcharge on certain businesses with more than \$250m in WA taxable income
  - Increases financial institutions surcharge from 1.2% to 1.5%
  - Increases advanced computing surcharge from 1.22% to 7.5%, increases annual cap per company from \$9m to \$75m

# **Operating Budget - Behavioral Health**

- \$500,000 for with a statewide mental health nonprofit organization that provides free community and school-based mental health education and support programs for consumers and families
- \$7.6 million for grants to support school-based health centers and behavioral health services
- \$5.3 million to continue existing street medicine contracts with Tacoma, Everett, and Spokane, as well as King and Kitsap County
- \$15 million for crisis relief facility grants

- \$14 million for a substance use or drug overdose prevention campaign
- \$9.5 million for health engagement hub pilot program sites
- \$6.9 million to expand distribution of naloxone to community health programs, other community settings, and first responders
- \$2.7 million to launch a tele-buprenorphine hotline to increase access to medications for opioid use disorder
- Various cuts to assisted outpatient treatment, short-term housing subsidies, BH-ASO jail services, recovery residences, and Medicaid MCO BH reimbursement rates.



## **Operating Budget - Public Safety**

- \$60.3 million for the Municipal Criminal Justice Account
- Funds 23 BLEA classes per year in 2026 and 2027, with two per year in each of four regional academies in Arlington, Pasco, Spokane, and Vancouver. Remaining classes in Burien.
  - Reinstates 25% local match for BLEA
- \$4 million to AWC to provide funds to cities to create alternative response team programs around the state
- \$3.6 million for public defense grants to cities
- \$1.2 million to decrease case backlogs for WSP toxicology
- \$9.5 million for law enforcement assisted diversion grants
- \$40 million for Recovery Navigator Program



# **Operating Budget - Housing & Homelessness**

- \$200 million for covenant homeownership program
- \$137 million for HEN program
- \$117.6 million for grants to local governments to maintain programs impacted by loss of document recording fees
- \$111 million for grants for local governments and NGOs for homeless housing programs and services
- \$90 million to transition those living in encampments to safer housing
- \$6.5 million for Consolidated Homeless Grant Program
- \$30.4 million for homeless families, youth prevention and diversion

- \$25 million for grants to support building operations, maintenance and service costs of permanent supportive housing projects
- \$22.5 million for housing assistance, including rental subsidies, permanent supportive housing, and low- and no-barrier housing beds for unhoused individuals
- \$1 million for diversions services for those at risk of losing stable housing or are homeless that are determined to have a high probability of returning to stable housing
- Various cuts to homeless identicard assistance, community support teams, housing assistance for people with complex conditions, and youth/young adult homelessness work group



# Capital Budget - Housing & Homelessness

- Housing Trust Fund \$536 million for housing to benefit low-income and special needs populations, including permanent supportive housing, including:
  - \$215 million multifamily rental housing
  - \$100 million for Apple Health & Homes
  - \$75 million for first-time low-income homeownership
  - \$50 million for housing for those with developmental disabilities
  - \$50 million for affordable housing preservation
  - \$30 million for mobile home park preservation

- \$10 million for rapid conversion or acquisition of housing to address extremely low-income and unhoused populations
- \$5 million for farmworker housing
- \$5 million for urgent repair grants
- \$90 million for Connecting Housing to Infrastructure (CHIP) grants to local governments
- \$14.7 million for recovery residences grants
- \$9 million for youth shelters and housing
- \$8 million for identified transit-oriented housing projects
- \$5 million for low-income home rehabilitation grants



# Capital Budget - Clean Energy & Climate

- \$30 million for High Efficiency Electric Appliance Rebates (HEAR)
- \$10 million for Clean Energy Community grants
- \$23 million for Community EV charging grants
- \$26 million for Clean Energy Fund program
- \$30 million for Weatherization Plus Health grants
- \$20 million for Solar and Energy Storage grants
- \$20 million for Energy Retrofits for Public Buildings grants
- \$5 million for Clean Buildings Performance grants

## **Transportation Revenue**

- Six cent gas tax increase plus 2% each year after
  - Cities to get 2.5% of the increase
- Motor vehicle sales tax increase from 0.3% to 0.5%
- Passenger and truck vehicle weight fee increases
- Title and registration service fee increases
- Rental car tax increased from 5.9% to 11.9%
  - Applies the rental car tax to peer-topeer vehicle sharing

- Luxury aircraft tax
- Luxury vehicles tax 8% tax on value over \$100k
- Tire disposal fee increase
- WSDOT work zone speed safety camera violations
- Driver's license and identicard fee increases
- Capital vessel surcharge increase (charged on ferry fares)
- Credit card surcharge on ferry fares



# **Transportation Budget**

- \$9.2 million to address homeless encampments on WSDOT-owned rights-of-way in coordination with local governments and social service organizations to direct people to housing and prevent future encampments including \$1 million for safety improvements and debris cleanup in Seattle
- \$10 million for Revive I-5 construction mitigation

- \$20 million for medium- heavyduty zero emission vehicle program
- \$25 million for deployment of alternative vehicle fuel charging and refueling infrastructure along state highways
- \$28 million for shorepower at Northwest Seaport Alliance
- \$26.5 million for port electrification grants

# **World Cup Funding**

- Public safety \$2.75 million for law enforcement and fire department resources, emergency management, traffic control, and security at official 2026 World Cup event venues, including fields and fan activation areas.
- Transportation
  - \$9 million for grants to transit agencies for enhanced service
  - \$4 million for transportation operations activities including incident response, operations center staffing, and signage improvements
  - \$3.65 million for transportation management and support, which includes public communications, digital advertising, and language access
  - \$5 million for intercity bus expansion
- Capital improvements
  - \$19.5 million for Washington State Public Stadium Authority
  - \$100,000 for Gonzaga practice field
  - \$1.7 million for University of Washington





## **Budget & Revenue**

- HB 1791 (Paul) Increases flexibility for local governments using REET revenues.
- HB 1858 (Scott) Removes the exemption for assignments or substitutions of previously recorded deeds of trust from the document recording surcharge and covenant homeownership program assessment.

### **Climate & Environment**

- HB 1018 (Shavers) Adding fusion energy to facilities that may obtain site certification for the purposes of energy facility siting.
- HB 1329 (Hunt) Concerning wholesale power purchases by electric utilities under the Washington clean energy transformation act.
- HB 1483 (Gregerson) Right to Repair, supporting the servicing and right to repair of certain products with digital electronics in a secure and reliable manner.
- HB 1543 (Doglio) Increasing compliance pathways for the clean buildings performance standard.
- SB 5627 (Ramos) Improving safe excavation practices and preventing damage to underground utilities.

### **Healthcare & Behavioral Health**

- HB 1813 (Macri) Concerning the reprocurement of medical assistance services, including the realignment of behavioral health crisis services for Medicaid enrollees.
- HB 1432 (Simmons) Improving access to appropriate mental health and substance use disorder services.
- HB 1427 (Davis) Concerning certified peer support specialists.

### **Housing & Homelessness**

- HB 1217 (Macri) Limits annual rent increases to 7% plus CPI or 10%, whichever is lower. New construction (less than 12 years old) is exempt.
- HB 1096 (Barkis) Increasing housing options through lot splitting.
- HB 1353 (Ramel) Establishing a self-certification program for accessory dwelling unit project permit applications.
- HB 1576 (Walen) Prohibits cities from designating a property as a historic landmark outside of a historic district if the property is less than 40 years old or, if the designation would restrict the use of the property and the property is less than 125 years old, if the property owner has not given written consent to the designation.
- HB 1491 (Reed) Promoting transit-oriented development.
  - 3.5 FAR density within half mile of rail station and 2.5 FAR density within quarter mile of bus rapid transit stops
  - 10% must be affordable or 20% must be workforce housing (does not apply to Seattle)
  - Creates new 20-year MFTE within station areas that meet affordability requirements
  - Applies to King County jurisdictions in 2029



## **Housing & Homelessness**

- HB 1621 (Macri) Authorizing superior courts to appoint housing court commissioners.
- HB 1696 (Taylor) Modifies the Covenant Homeownership Program by raising the area median income threshold for eligibility to 120 percent and authorizing full loan forgiveness under certain circumstances.
- SB 5184 (Bateman) Concerning minimum parking requirements.
  - Prohibits cities and counties from requiring more than 0.5 parking space per residential dwelling unit.
  - Prohibits cities and counties from requiring more than one parking space per 1000 square feet of commercial space.
  - Prohibits cities and counties from requiring any minimum parking requirements for existing buildings undergoing change of use and various other categories of residential and commercial buildings
- SB 5571 (Bateman) Prohibits a city from requiring or excluding exterior cladding materials that are in compliance with the state building code.



#### **Labor & Commerce**

- HB 1747 (Ortiz-Self) Expanding protections for applicants and employees under the Washington fair chance act.
- SB 5041 (Riccelli) Making striking or lockout workers eligible for unemployment insurance benefits.
- SB 5101 (Valdez) Expanding access to leave and safety accommodations to include workers who are victims of hate crimes or bias incidents.
- SB 5786 (Saldaña) Increases fees for various liquor licenses, permits, and endorsements.

## **Public Safety & Criminal Justice**

- HB 1163 (Berry) Enhancing requirements relating to the purchase, transfer, and possession of firearms.
- HB 1498 (Davis) Domestic violence co-responder programs.
- HB 1811 (Salahuddin) Enhancing crisis response services through co-response integration and support.
- SB 5202 (Salomon) Ensuring the efficacy of judicial orders as harm reduction tools that increase the safety of survivors of abuse.
- SB 5745 (Dhingra) Concerning appointed counsel for individuals detained under the involuntary treatment act.

# **Social Programs & Education**

- HB 1296 (Stonier) Promoting a safe and supportive public education system.
- HB 2049 (Bergquist) Increases the maximum per-pupil limit used for school enrichment levies.
- SB 5232 (Wilson, C.) Updating eligible uses for the essential needs and housing support program.

## **Transportation**

- SB 5801 (Liias)
  - Includes high capacity transportation system improvements as essential public facilities under the GMA (effect is prohibits local governments from precluding the siting of the facilities).
  - Specifies that cities and counties (1) may not preclude the siting of high capacity transportation system improvements by imposing conditions or costs that are not reasonably necessary to mitigate adverse impacts directly caused by the improvements and (2) will commit to reasonable timelines to ensure timely issuance of permits without unnecessary delay. The essential public facility shall provide the city or county with the information needed to make timely permitting decisions.
  - Authorizes the imposition of tolls on the entire SR 520 corridor, instead of just the floating bridge, including on-ramps and off-ramps.
  - Creates a program to compensate registered tow truck operators for the cost of towing, storage, and other services incurred during the towing of an indigent person's vehicle.
