 City of Seattle

- Seattle Fire Department is represented on the State Building Code Council Fire Code Technical Advisory Group which reviews all proposed changes to the WA State Fire Code.
- The Seattle Fire Code is based on the International Fire Code and the WA State Fire Code.
- Codes are on a 3-year cycle. (2018,2021,2024 2027 etc.)

# Seattle Fire Code Advisory Board

- Established by resolution in 1957.
- Advisory-decisions are not binding, but Fire Department and Elected Officials rely heavily on recommendations and expertise of this Board.
- 15 members: Architect, chemical engineer, mechanical engineer, BOMA, King Co Labor Council, major institutions, fire insurance industry, manufacturing and warehousing, marine industry, Port of Seattle, services industry, research labs, fire protection industry, and two public positions.

# Seattle Fire Code Advisory Board

- Board members are appointed by the Mayor and confirmed by the City Council.
- Three-year terms for each position.
- No compensation for service on board.
- Board hears Fire Code appeals and makes recommendations to the Fire Chief and Fire Marshal.

- They also review Statewide Fire Code amendments that could impact the City of Seattle.

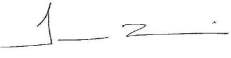

### Section 1. SCOPE

This rule shall apply to inspection, testing, maintenance and reporting requirements for fire protection and life safety systems, private fire hydrants, and emergency responder communication enhancement systems, and equipment as defined in the Seattle Fire Code, and any other systems as set forth by the fire code official.

#### Exceptions:

1. NFPA 13D sprinkler systems.

- The Fire Marshal develops Administrative Rules that help to enforce and clarify Seattle Fire Code requirements.
- The Seattle Fire Code Advisory Board reviews these and they provides any recommended changes.
