4 AN ORDINANCE relating to City employment; exempting positions from the civil service
5 system; returning positions to the civil service system; and amending Section 4.13.010 of
6 the Seattle Municipal Code; all by a 2/3 vote of the City Council.

7 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

8 Section 1. Exempting one position from civil service status. As requested by the
9 department in the Classification Determination report specified, the following position is
10 exempted from civil service:

11 - 1 filled position (00024071) in the Seattle Department of Human Resources, Manager 3,
12 Exempt (Report # 22235)

13 Section 2. Returning four positions to civil service status. As requested by the department
14 in the Classification Determination Report specified, the following positions are returned to the
15 civil service:

16 - 1 filled position (00019593) in the City Attorney's Office, Paralegal - Law (Report #
17 22392)

18 - 1 filled position (10004480) in the Seattle Department of Human Resources, Manager 2,
19 General Government (Report # 22038)

20 - 1 vacant position (10005054) in Seattle City Light, Strategic Advisor 1, Utilities L21C
21 (Report # 22643)

22 - 1 filled position (10006479) in Seattle City Light, Manager 2, General Government
23 (Report # 22553)

Section 3. Section 4.13.010 of the Seattle Municipal Code, last amended by Ordinance 126824, is amended as follows:
