Dear Commissioners:

I write to express my sincere interest in joining the Community Police Commission in its mission to amplify the voices of Seattle's diverse communities affected by policing. I was encouraged to apply by Roxana Pardo Garcia. Roxana and I met as student activists at the University of Washington where I facilitated a gender and sexuality workshop for a conference Roxana organized for Latinx high school students. In the years since, I have remained committed to the pursuit of equity and social justice. As you will see from my attached resume, I have worked with many of the populations most impacted by policing, including people with disabilities, justice-involved individuals, the LGBTQIA community, and immigrants. My professional and lived experience has greatly demonstrated the critical need for a police system that is fully aligned with the communities it is mandated to protect and serve.

At Disability Rights Washington, I am part of a team dedicated to protecting and advancing the rights of inmates with disabilities. I provide legal rights information, appropriate referrals, and self-advocacy tips to dozens of inmates each month to support their efforts to advocate for their expressed goals. When addressing systemic issues and problematic individual cases, I value transparent and productive collaboration with jail and Department of Corrections administrators and staff.

Due to DRW's federal access authority, I am also able to monitor conditions within prisons and jails, such as the King County Correctional Facility in downtown Seattle. Jails, in particular, have an overrepresentation of people with mental illness, substance use disorders, and homeless individuals. During our conversations, detainees with mental illness frequently raise their concerns about their arrest encounters as well as their general repeated interactions with police. These discussions further demonstrate to me that police accountability is a public and behavioral health issue as much as it is a civil rights one.

My professional advocacy has not been limited to my current role. Previously, as the Social Justice Programmer at the University of Washington's Q Center, I developed and facilitated workshops and trainings for students, staff, faculty, and community members on the intersections of race, sexual orientation, and gender identity. There I was able to hone a skillset for creating social-justice-oriented learning environments that were welcoming while still constructive.

Ultimately, it has been active engagement with community that has grounded my work. I am a member of the new and growing western Washington chapter of ADAPT, a disability justice collective. Recently, I accepted an invitation to join the Eritrean Health Board in its efforts to address the public health concerns of the Eritrean immigrant and refugee community in King County. More broadly, I choose to engage within community spaces whenever possible and appropriate to support the larger movement for a more just and equitable world.

In October, I was humbled to assist in filming a video of one Washington family's story of the police shooting death of their son and father for the De-Escalate Washington campaign. I am thrilled by the passage of both I-940 by our state legislature and last year's accountability legislation by Seattle City Council. Although there has been notable progress championed by incredibly hard-working people, I feel the same urgency today as I did the day the Department of Justice began its investigation into the Seattle Police Department. There is a long road of necessary work ahead.

As a black disabled woman, I am personally invested in the systemic transformation of policing. I believe that this personal stake as well as my professional knowledge and experience provide me with valuable insights and the ability to reciprocally engage with communities that are extremely relevant to ensuring the goals of the Community Police Commission.

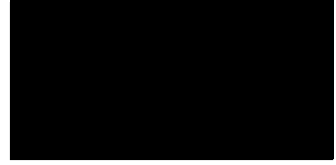
