Chip Nevins DPR Greenwood-Phinney Park 2015 Add ORD April 14, 2015 Version #1a2 1 CITY OF SEATTLE 2 ORDINANCE _____ 3 COUNCIL BILL _____ 4 ..title 5 AN ORDINANCE relating to the Department of Parks and Recreation; authorizing the 6 acquisition of real property commonly known as 8118 Greenwood Avenue North; 7 authorizing acceptance and recording of the deed for open space, park, and recreation 8 purposes; and ratifying and confirming certain prior acts; all by a three-fourths vote of the 9 City Council. 10 ..body 11 WHEREAS, by Resolution 31055 the City Council created the Parks and Green Spaces Levy 12 Citizens' Advisory Committee to ensure citizen participation in the development of a 13 potential package of parks, open space, boulevards, trails, green infrastructure, and 14 recreation projects, and a proposed set of options to fund the package; and 15 WHEREAS, the Parks and Green Spaces Levy Citizens' Advisory Committee, after being duly 16 appointed and spending many hours in open meetings, receiving public testimony and deliberating on the levy, voted by a strong majority to recommend that the City Council 17 place a \$145.5 million six-year levy proposal for park purposes before the voters of 18 19 Seattle; and 20 WHEREAS, in response to this recommendation, the City Council passed Ordinance 122749, 21 placing Proposition 2, the 2008 Parks and Green Spaces Levy, before the voters of 22 Seattle; and 23 WHEREAS, the 2008 Parks and Green Spaces Levy was approved by Seattle voters on 24 November 4, 2008; and 25 WHEREAS, Ordinance 122749 identifies the Greenwood-Phinney Ridge Residential Urban 26 Village for a potential neighborhood park acquisition; and

Chip Nevins DPR Greenwood-Phinney Park 2015 Add ORD April 14, 2015 Version #1a2 WHEREAS, the Department of Parks and Recreation considers the Greenwood-Phinney Ridge 1 2 Residential Urban Village as significantly underserved with quality open space, and a 3 priority area for additional acquisitions for parks and open space; and 4 WHEREAS, the City has determined that the property at 8118 Greenwood Avenue North, 5 adjacent to 8100 Greenwood Avenue North, will allow for a bigger neighborhood park to 6 address the open space needs of the Greenwood-Phinney Ridge Residential Urban 7 Village and that it is in the public's best interest to acquire the same for open space, park, 8 and recreation purposes; NOW, THEREFORE, 9 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: 10 Section 1. Section 2. The Superintendent, or the Superintendent's designee, is authorized, on behalf of The City of Seattle, to acquire the Property substantially in accordance with the terms and conditions of execute the a Purchase and Sale Agreement substantially in the form attached hereto as Attachment 1 ("Agreement") for the acquisition of the Property. The Superintendent is authorized to execute such additional documents as deemed necessary or desirable to accomplish acquisition of the Property, including, without limitation, such consents, approvals, extensions of time, and minor amendments of the Agreement as deemed appropriate to carry out the intent of this ordinance. Upon delivery of the statutory warranty deed for the Property, the Superintendent is authorized to accept the deed on behalf of The City of Seattle by attaching written acceptance to the deed, and to record the same. The Property shall be accepted for open space, park, and recreation purposes, and placed under the jurisdiction of the Department of Parks and Recreation.

Section 3. Any acts consistent with the authority and prior to the effective date of this ordinance are hereby ratified and confirmed.
