RCW 35.32A.090(1) states, "There shall be no orders, authorizations, 21 allowances, contracts or payments made or attempted to be made in excess of the expenditure 22 allowances authorized in the final budget as adopted or modified as provided in this chapter, and 23 any such attempted excess expenditure shall be void and shall never be the foundation of a claim 24 against the city."
