1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to the Department of Parks and Recreation; authorizing the Superintendent of Parks and Recreation to enter into an Agreement with the Washington State Department of Transportation (WSDOT) to accept and expend funds provided by WSDOT to implement the design and construction of certain recreational improvements as mitigation measures for the recreational impacts of the Portage Bay Bridge Roanoke Lid portion of the SR 520, I-5 to Medina: Bridge Replacement and HOV Project; amending Ordinance 126725, which adopted the 2023 Budget, changing appropriations to various departments and budget control levels, and from various funds in the Budget.

Summary and Background of the Legislation: WSDOT applied to the City for approval of a Shoreline Substantial Development Permit for the Portage Bay Bridge Roanoke Lid portion of the SR 520, I-5 to Medina: Bridge Replacement and HOV Project and on July 28, 2022, the Seattle Department of Construction and Inspections issued its Analysis and Decision, conditionally approving the Shoreline Substantial Development Permit. WSDOT wishes to satisfy the conditions contained within the Shoreline Decision, and one of the conditions of the Permit requires that WSDOT provide \$700,000 to Seattle Parks and Recreation Department to support the design and construction of certain recreational improvements as mitigation measures for recreational impacts of the Portage Bay Bridge Project. Seattle Parks and Recreation seeks authorization to accept and spend the funds from WSDOT and enter into an agreement with WSDOT whereby SPR agrees to implement the design and construction of certain recreational improvements as mitigation measures for the recreational impacts of the Portage Bay Bridge Project.
