Geoff Wentlandt/Jonathan Morales OPCD Lake City Rezone ORD 1 CITY OF SEATTLE 127290 ORDINANCE 2 COUNCIL BILL 121049 3 4 AN ORDINANCE relating to land use and zoning; amending Chapter 23.32 of the Seattle Municipal Code (SMC) at page 8 of the Official Land Use Map to rezone land in the 5 Lake City neighborhood. 6 7 WHEREAS, the Lake City Community Center was severely damaged by fire in 2023 and Seattle 8 Parks and Recreation and the Seattle Office of Housing are partnering to pursue an 9 innovative project to rebuild the community center in a mixed-use building with a new 10 community center at the ground level and multiple stories of affordable housing above it; 11 and 12 WHEREAS, Seattle continues to face significant housing affordability challenges as an 13 estimated 32 percent of all households in the city are cost burdened, and of these, close to 14 50,000 households are severely cost-burdened and at especially high risk of housing 15 insecurity; and 16 WHEREAS, new rent- and income-restricted affordable housing is one of the most direct ways 17 the City can support affordable housing for its residents and aid community members at 18 risk of displacement; and 19 WHEREAS, rebuilding a new Lake City community center is a high priority for residents and 20 workers in Lake City and a new community center will provide an important public 21 service to households throughout Lake City and adjacent neighborhoods; and 22 WHEREAS, this ordinance would increase development capacity for housing and community 23 serving uses and maintain a Mandatory Housing Affordability requirement on a group of 24 parcels that include currently lightly used or vacant properties; and

1	WHEREAS, this proposal will be compatible with the planned land use pattern envisioned in the
2	Comprehensive Plan and the Seattle Municipal Code, since the proposal meets rezone
3	criteria, and would be consistent with the precedent of the mix of uses in other nearby
4	areas and would provide a more gradual stepped transition between higher intensity and
5	lower intensity zoned areas; and
6	WHEREAS, a State Environmental Policy Act (SEPA) Determination of Non-Significance
7	(DNS) was issued on June 9, 2025; and
8	WHEREAS, the proposed rezone meets criteria in the Land Use Code as discussed in the
9	Director's Report accompanying this ordinance; NOW, THEREFORE,
10	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
11	Section 1. The Official Land Use Map, Chapter 23.32 of the Seattle Municipal Code, is
12	amended to rezone properties identified on page 8 of the Official Land Use Map as shown on
13	Attachment 1 to this ordinance.
