1. BILL SUMMARY

Legislation Title: A RESOLUTION providing an honorary designation of South Mount Baker Boulevard between 31st Avenue South and 32nd Avenue South as "Cheryl Chow Boulevard."

Summary and Background of the Legislation:

This legislation would establish an honorary designation of South Mount Baker Boulevard adjacent to Franklin High School as "Cheryl Chow Boulevard." Cheryl was a long-time mentor and coach with the Seattle Chinese Girls Drill team and Seattle Chinese Athletic Association, and served on the Seattle City Council and the Seattle School Board. In her last days, Cheryl spoke up and came out as a member of Seattle's lesbian, gay, bisexual, transgender, queer, intersex, and asexual (LGBTQIA+) community, hoping to help younger Asian Americans feel comfortable in their own bodies.

The cost of fabricating and installing the signs will be reimbursed to the City by a private party.
