Payment of the sum of \$20,243,120.67 on Summit mechanical warrants 8 numbered 4002527024 – 4002530722 plus manual or cancellation issues for claims, E-Payables 9 of \$85,741.82 on Summit 9000021099 - 9000021185 and Electronic Financial Transactions 10 (EFT) in the amount of \$33,579,896.81 are presented for ratification by the City Council per 11 12 Chapter RCW 42.24.180. Section 2.
