### **1. BILL SUMMARY**

**Legislation Title:** AN ORDINANCE relating to land use and zoning; adopting a moratorium on the filing, acceptance, processing, or approval of applications for the establishment, expansion, or change of use for detention centers; adding a definition for detention centers; amending Section 23.84A.008 of the Seattle Municipal Code; approving a work plan; declaring an emergency; and establishing an immediate effective date; all by a 3/4 vote of the City Council.

#### **Summary and Background of the Legislation:**

This legislation would: (1) make findings of fact related to the lack of current regulations in the Seattle Municipal Code for detention centers and the potential impacts of those facilities, absent regulations, on the public health, safety, and welfare; (2) declare a public emergency; (3) define “detention center” consistent with the definition in RCW 36.70A.200(1)(b); (4) establish a year-long moratorium on permit applications for development, expansion, or conversion of existing structures to detention centers; and (5) establish a work plan to consider permanent regulations by January 2027

The legislation would be adopted on an emergency basis and immediately effective. Pursuant to RCW 36.70A.390, the Council would hold a public hearing on the legislation within 60 days after passage. The moratorium in the legislation would be effective for one year and may be renewed for one or more additional six-month periods.
