1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to the Seattle Preschool Program Levy; and approving a partnership agreement between The City of Seattle and the Seattle School District No. 1, as required by Ordinance 124509.

Summary and background of the Legislation:

This legislation approves a Seattle Preschool Program Levy Partnership Agreement as required by Section 12 of Ordinance 124509. Ordinance 124509, which authorized a \$58 million, 4-year Seattle Preschool Program Levy ("Levy") package, directs that before any levy funds can be expended for School District programs, the City of Seattle and the Seattle School District must have an effective Partnership Agreement that has been approved by both the Seattle City Council and the Seattle School District. The Partnership Agreement, attached to this Council Bill, affirms that all Levy funds will be invested to achieve Levy outcomes in school readiness. It lists City and Seattle School District principles, roles, and responsibilities toward achieving school readiness.

By not implementing this legislation, the City will not be able to invest all of the funding available to support children and their families through the voter-approved Seattle Preschool Program Levy passed in November 2014. Funds that are intended to be awarded to the School District would not be approved and Seattle's children who would have been served by District programs would not receive preschool services beginning in the 2015-2016 school year.
