| 6 | Section 1. The City Council finds and declares that The City of Seattle is in compliance |
| 7 | with and meets all requirements contained in RCW 43.101.540 and RCW 82.14.345(c). |
| 8 | Section 2. A new Section 5.60.029 is added to the Seattle Municipal Code as follows: |
| 9 | 5.60.029 Imposition of sales and use tax for criminal justice purposes |
| 10 | A. There is imposed a sales and use tax as authorized by RCW 82.14.345, upon every |
| 11 | taxable event, as defined in chapter 82.14 RCW, occurring in Seattle. The tax shall be imposed |
| 12 | upon and collected from those persons from whom the state sales tax or use tax is collected |
| 13 | pursuant to chapter 82.08 and 82.12 RCW. |
| 14 | B. The rate of the tax imposed by this Section 5.60.029 shall be 0.1 percent of the selling |
| 15 | price or value of the article used. |
| 16 | C. The City may use the moneys imposed under this Section 5.60.029 for criminal justice |
| 17 | purposes as defined by RCW 82.14.345. |
| 18 | Section 3. Sections 5.60.030 and 5.60.040 of the Seattle Municipal Code, last amended |
| 19 | by Ordinance 125887, are renumbered and amended as follows: |
| 20 | ((5.60.030)) <u>5.60.065</u> Administration ((and collection of tax)) |
| 21 | A. The administration and collection of the taxes imposed by this Chapter 5.60 shall be in |
| 22 | accordance with the provisions of RCW 82.14.050 ((and Chapter 338, Laws of 2019)) , RCW |
| 23 | 82.14.345, and RCW 82.14.540. |
