Section 5.73.120 of the Seattle Municipal Code, last amended by Ordinance 19 127016, is amended as follows: 20 5.73.120 Expiration of program 21 Except for extension of property tax exemptions as authorized in subsection 5.73.090.D, the tax 22 exemption program established by this Chapter 5.73 shall sunset on ((December 31, 2024)) 23 March 31, 2025, unless extended by the City Council by ordinance. After the program sunsets,
