WHEREAS, a proposed plat of "Valley Street Townhomes" has been submitted for approval Seattle Department of Construction and Inspections (SDCI) Permit No. 3017479, and WHEREAS, following review and recommendations by the various City departments that have jurisdiction in this matter and a public hearing by the Hearing Examiner of The City of Seattle on February 8, 2016, the Hearing Examiner approved the preliminary plat of "Valley Street Townhomes" subject to certain conditions on February 10, 2016; and WHEREAS, SDCI has confirmed that the preliminary plat conditions have been satisfied; and WHEREAS, the Director of Transportation and the Director of SDCI have, subject to Council approval, approved the final plat and have reported that the final plat now meets all of the requirements of the State platting law (chapter 58.17 RCW) and of the Seattle Municipal Code (Chapter 23.22), except for the execution of the required certifications by the King County Assessor and the King County Finance Division; and WHEREAS, the Director of Transportation and the Director of SDCI report that the plat of "Valley Street Townhomes", a copy of which is in Clerk File 314285, is now complete and ready for City Council approval; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

1	Section 1. The plat of "Valley Street Townhomes," a platting of portions of the				
2	Southwest Quarter of the Northwest Quarter of Section 30, Township 25 North, Range 4 East,				
3 .	W.M., all in King County, Washington, is legally described as follows:

11	SITUATE IN THE COUNTY OF KING, STATE OF WASHINGTON.				
12	Section 2. With respect to the plat of "Valley Street Townhomes," together with any				
13	interest in abutting streets, as executed by Christopher Jolley as Managing Member and approved				
14	by the Director of Transportation and the Director of the Seattle Department of Construction and				
15	Inspections, the following findings are hereby made:				
16	(a) The final plat is in substantial conformance with the approved preliminary plat;				
17	and				
18	(b) When both the King County Assessor and King County Finance Division have				
19	affixed their certifications as required by RCW 58.17.160(4), the requirements of State law and				
20	City ordinances that were in effect at the time of preliminary plat approval will also have been				
21	satisfied by the subdivider; and				
22	(c) The public use and interest will be served by the establishment of the plat, and the				
23	plat makes appropriate provision for the public health, safety, and general welfare.				
24	Section 3. The plat of "Valley Street Townhomes," a subdivision of portions of the				
25	Southwest Quarter of the Northwest Quarter of Section 30, Township 25 North, Range 4 East,				
26	W.M., King County, Washington, is in all respects approved and the plat confirmed and				
27	accepted, subject to certification by the King County Assessor and King County Finance
